[St. Louis City Emergency Management Agency \(CEMA\) Director Sarah Russell was placed on paid administrative leave Tuesday, by city Mayor, Cara Spencer, for her failure to activate the city's emergency sirens prior to last Saturday's EF3 tornado. Russell was at a "workshop", reports say.](#)
