## A Second Look At AG Jeff Sessions

#### THE WAR ON POLICE

Just what has A.G. Sessions been doing? I found the answer in the June 2017 *The Schwarz Report* article entitled "THE WAR ON

POLICE" BY Heather MacDonald. After the election of President Barack Obama and the fatal shooting of Michael Brown in Ferguson, Missouri in August 2014, officers were backing off of proactive policing and violent crime was rising. In 2015, we saw the largest one-year spike in homicides nationwide in nearly 50 years and continued unabated through 2016 and into the 2017.

The federal government's practice of slapping years-long Consent Decrees on police departments called out for reform. There is zero chance that Civil Rights attorneys in the federal government know more than police departments do about how to fight crime constitutionally and successfully. Yet the Obama administration opened 25 "pattern-or-practice" Civil Rights investigations, based on the false notions that police bias was widespread and that federal lawyers are qualified to recommend effective police practices. The Department of Justice was currently enforcing 14 Consent Decrees with local departments, which grew out of such investigations. At a minimum, the Trump administration should have published data on how much the Obama-era-investigations and Consent Decrees have cost those departments.

At the end of March 2017, Sessions announced a review of existing and pending Consent Decrees. The immediate target of this review was a Consent Decree for the Baltimore Police Department, hastily signed in the waning days of the Obama administration and at that point still awaiting final approval from a federal judge. Session's reevaluation was fully justified. As is typical, the Obama-era DOJ report that preceded the Baltimore decree failed to put numbers behind its charge that the Baltimore PD engaged in a "pattern or practice" of unconstitutional policing. The Obama report blasted the Baltimore cops for "clearing the corners" of miscreants and loiterers, but the police engage in such corner-clearing at the behest of the community. Since the report came out in summer 2016, Baltimore neighborhoods have been overrun by drug dealers, who now believe that they can operate with impunity. Residents have begged the department to return to corner-clearing and other public-order enforcement. The policing-is-racist narrative in Baltimore found five of the seven indicted officers were black ending up with a depleted and demoralized police force and to tens, if not hundreds of millions of dollars of unnecessary costs and fees.

From Baltimore, the next target for the A.G. Sessions Consent Decree review was an as-yet unfinalized Consent Decree in Chicago. The Obama-era report that triggered the pending Consent Decree suffered from the same flaws as the Baltimore report — it provided no quantified evidence for its claim that the Chicago Police Department engaged in systemic Civil Rights abuse. The mayhem in Chicago in February and March 2017 alone included the slaying of a two-year-old boy and two other children in separate drive-by shootings over four days, and the spread of rape, robberies, car jackings and kidnappings into downtown and other previously safe neighborhoods.

And then in 2012 police Consent Decree in New Orleans, for example, was projected to cost \$55 million over five years but the actual costs would be much higher. Recent news reports said that sexual-assault complaints rose in 2015 (allegedly suggesting greater "gender" sensitivity in the New Orleans Police Department) and New Orleans is in the midst of an ongoing violent-crime spike shootings and homicides more than doubled in January 2017 over January 2016.

Obama's first attorney general, Eric Holder, called on local US attorneys to involve themselves in prisoner reentry and rehabilitation activities. Heather McDonald said the Trump administration should determine if that initiative is producing enough crime reduction to justify the diversion of scarce prosecutorial resources; arguably, reentry activities are most efficiently carried out by the US Probation officers. Federal prisons, on the other hand, can serve as a model for prison work policies and prisoner education. The Bureau of Prisons should partner with private business for job-skills development, as recommended in the Sentencing Reform and Corrections Act of 2015.



# A.G. SESSIONS UNDOES OBAMA'S UNCONSTITUIONAL FOOFARAW

And then we have recently declared sanctuary cities, counties, and states that must be severely penalized. These scofflaw jurisdictions mainly controlled by Democrats that number about 300, refuse to cooperate with Immigration and Customs Enforcement (ICE) efforts to deport convicted illegal-alien criminals must be penalized, so it seems obvious to me that A.G. Sessions has been going quietly about the business of undoing all the damage to the system that President Barack Obama caused and without the media reporting something positive.

### TRUMP'S PROMISE TO RESTORE ORDER

Perhaps Judge Jeanine forgets that Donald Trump vigorously defended law enforcement during his presidential campaign. He pledged to restore order to the nation's cities – where violent crime is surging and primarily in black neighborhoods. The administration should explain that datadriven, proactive policing made possible the country's 20 year, 50 percent violent-crime decline that began in the mid-1990s.

Recognizing that the Mueller investigation was FAKE and a waste of tax dollars, perhaps Trump and A.G Sessions decided to devote their time on the war we've seen on our police thereby encouraging them to be more proactive rather than purely reactive and responding only to crimes after someone has been victimized?

In February, 2018 Sessions made a good start in turning around the false narrative about policing, addressing the National Association of Attorneys General. Session warned that the nation's violet-crime decline is now at risk, while acknowledging that the crime increase is not happening in every neighborhood. Yet we are diminished as a nation, he said, when citizens "fear for their life when they leave their home." To be blunt, the violent-crime increase has hit almost exclusively in black neighborhoods.

Believing that A.G. Sessions is a weak scallywag, God brought to my mind the story of Moses, Joshua and Gideon. Moses lived to be 120 years old (Deut. 34:7) but it wasn't until he was 80 years old (Ex. 7:7) that God called him to lead His people out of Egypt. Compare this to the 7 Last Plagues of Revelation that will not fall on God's people. Also note this indicates that God's people will still be here on this earth during the Tribulation years. (Rev. 7:3; 9:4)

After leaving Egypt the Israelites passed through the Red Sea, were given Manna to eat and water to drink, were reminded of the Laws of God at Mr. Sinai and saw many other manifestations proving that it was God who was leading them, but when they finally arrived at the Land of Canaan they still did not trust God. Because of their distrust they were forced to spend a total of 40 years in the wilderness before they trusted God enough to actually do what he told them to do.

At one point, while on the way to the Promised Land (during their 40 years of wandering), the people complained of not having water. God told Moses to speak to a specific rock and He would send water but Moses lost his temper with the people and all their bellyaching and struck the rock twice (Numbers 20).
