The purpose for joining with the other parties was to bring about more trade, more opportunities for more jobs — in short, for a better life for business and the people; but all this is headed in the opposite direction. What's going on here?

The United Nations is using trade as the bait to suck all nations into one global entity of complete economic, cultural and political control, i.e., the New World Order, or Global Governance. And to implement this on-going plan, the UN is using local change strategies such as Agenda 21 to introduce and incrementally facilitate change through state and local governments which will bring a mind-set more favorable to global governance.

### Agenda 21 Connection

It is difficult to define the connection of Sustainable Development and Agenda 21. <u>Agenda 21 is a part of Sustainable Development</u>, and is the vehicle which advances sustainable development.

Let's take a look at some of the people behind all this activity, as well as what they propose and endorse.

William F. Jasper, editor of the New American Magazine attended the 1992 Earth Summit, known officially as the United Nations Conference on environmental Development (UNCED), the

eco-confab in Rio de Janeiro, Brazil. It was unprecedented in size and scope, bringing together some 35,000 government officials, diplomats, NGO activists, and journalists. According to Jasper, Rio became the launch pad for a number of huge initiatives that have been gradually gaining force and wreaking havoc on the planet in intervening decades; one of the main documents to come out of UNCED process was Agenda 21.

The ICLEI (International Council for Local Environmental Initiatives) web page states that its Local Agenda 21 Model Communities Programme is "designed to aid local governments in implementing Chapter 28 of Agenda 21," the global action plan for sustainable development.

#### ICLEI's website informs us:

The Council was established when more than 200 local governments from 43 countries convened at our inaugural conference, The World Congress of Local Governments for a Sustainable Future, at the United Nations in New York.

ICLEI's website notes that in 2003 it changed its name "ICLEI – Local Governments for Sustainability," no doubt to place more emphasis on the "local" and to diminish concerns about its "international" influence and its political and financial ties to the United Nations. ICLEI and other UN-affiliated NGOs and government officials have come under increasing suspicion in recent years from American citizens, and have taken to camouflaging their UN-driven environmental agendas, even to the point of denying obvious and easily documented connections. On its web page entitled "ICLEI Connecting Leaders," ICLEI explains some of its networking strategies. They include:

Connect cities and local governments to the United Nations and other international bodies. ICLEI represents local governments at the United Nations (UN) Commission on Sustainable Development, the UN Framework Convention on Climate Change and the Conventions on Biodiversity and Combating Desertification and cooperates with the UN Environment Programme and UN-HABITAT.

"That seems pretty clear: ICLEI's mission is to "connect" local governments to the UN and its affiliates. It goes on: "

Mobilize local governments to help their countries implement multilateral environmental agreements such as the Rio conventions through Cities for Climate, Protection, and Local Action for Biodiversity and other initiatives.

Again, fairly straightforward: Get the locals to lobby and pressure the national government to hop on board the global programs that will transfer more money, authority, and power to the UN. ICLEI continues:

Forge multi-stakeholder partnerships such as Resilient Cities, a global framework on urban resilience and climate adaptation where local governments, international agencies, development banks, ministries, institutions, and others collaborate.

Translation: bribe, entice, seduce, flatter local officials, NGOs, and corporations to join the green lobby.

According to William F. Jasper, in the New American Magazines article, "Your Hometown & the United Nations' AGENDA 21," although the Climate Change Convention has dominated the media headlines and political landscape for many years, Agenda 21 is even more far-reaching and dangerous. Jasper points out that the alarmists declare that desperate measures are necessary to "save" Mother Earth, and only a comprehensive, global plan will do. He admits that UN Agenda 21 is definitely comprehensive and global. It proposes a global regime that will monitor, oversee, and strictly regulate our planet's oceans, streams, rivers, aquifers, sea beds, coastlands, wetlands, forests, jungles, grasslands, farmland, deserts, tundra, and mountains — in short, everything. There is nothing on, in, over, or under the Earth that doesn't fall

within the purview of some part of Agenda 21.

According to the report. The most accessible of Agenda 21 to come out following the Rio summit was published under the title Agenda 21: "The Earth Summit Strategy to Save Our Planet," edited by environmental-activist attorney Daniel Sitarz, and enthusiastically endorsed by now deceased Earth Summit chief Maurice Strong. The book is instructive for demonstrating the completely alien mindset that holds sway in so many influential political, academic, and media circles. Sitarz's edition provides a powerful, albeit unintended, indictment of the UN agreement by offering this candid appraisal of the plan's totalitarian ambition. Incredibly, Sitarz admits with apparent approval that:

Agenda 21 proposes an array of actions which is intended to be implemented by every person on Earth... It calls for specific changes in the activities of all people... Effective execution of Agenda 21 will require a profound reorientation of all human society, unlike anything the world has ever experienced — a major shift in the priorities of both governments and individuals and an unprecedented redeployment of human and financial resources. This shift will demand that concern for environmental consequences of every human action be integrated into individual and collective decision-making at every level.

One might ask, what does all this have to do with the renegotiated NAFTA — the USMCA? If the USMCA is ratified it will bring in by the back-door the UN Law of the Sea Treaty that will not only aid in implementing much of what is planned in Sustained Development through Agenda 21, but so much more. However, even if there wasn't anything else to avoid, what is imbedded in this one Chapter 24 is more than enough to outright reject this USMCA trade deal.

And that, Mr. President is what you should do. You shouldn't even let it come to a vote. I'm sure you intended that it be renegotiated to a positive result — positive to Americans

sense of values. Of course, as we now see this hasn't been done. But if it is allowed to come before Congress and the Senate it will probably be ratified. There are many legislators who are supposedly on our-side, but too many who are not.

As I said in my "Open Letter to you, part 1," the ball is in your court. Mr. President, millions of Americans are hoping you will step up to the plate and do the right thing — pull completely out of it.

If you choose not to, let's look at the consequences, it will mean that you will have broken your promise. And that is most likely to result in about 30 percent of your supporters staying home in 2020. And I hate to even think about the consequences.

## Open Letter To President Donald J. Trump, Part 1

Dear Mr. President:

It appears to many of us that you don't really know what some of the people in your administration are up to. I believe you are being ill-advised by those in your administration who have a totally different agenda. #### NAFTA v USMCA

Mr. President, you have told us for some time that you were going to renegotiate NAFTA to our benefit or you would pull out of it completely. Now that it has been renegotiated, it certainly is not to our benefit. In fact, the new version is even worse than the original.

The New American Magazine posted an article by Christian Gomez, entitled, "NEW NAFTA: Text of U.S.-Mexico-Canada Agreement (USMCA) Sir, I am humbly asking you to read this very important article. It outlines the problems with the new agreement to replace NAFTA and Mr. Gomez definitely believes they are worse. In fact, what I have read thus far leaves no doubt in my mind that he is right.



The proposed USMCA has been widely portrayed as a replacement for NAFTA, which supposedly will no longer exist. Yet an honest look at the new agreement shows that what will no longer exist is the highly unpopular NAFTA name.

Not only does the USMCA retain sovereignty-diminishing provisions found in the NAFTA agreement, but it actually strengthens and expands them.

Let me present an example of one of the many absurdities I find in this proposal.

In a bold step toward a potential North American Union, The USMCA establishes a new governing international bureaucracy. Chapter 30 of the agreement establishes the creation of a Free Trade Commission as a regional governing bureaucracy overseeing various lower regional committees.

Beneath the Free Trade Commission, the USMCA authorizes all three countries to establish 16 subordinate committees and each committee will have a representative from each country; and the possibility exists that each of these committees will have someone in charge, like a chairperson. We have  $16 \times 3$  equals  $48 \times 3$ , or maybe 4, this could mean that these 16 committees could have a staff of at least 144 and possibly 192, all of whom are unelected by the people.

Something else which surfaces out of all this conglomeration of committees and commissions and humongous amounts of staff...most likely, all these heads of the various commissions will be insiders who will be chosen by the hierarchy of the USMCA. That being the case, we can reasonably expect

practically all these staff to work towards the unspoken objectives of the USMCA — the successful fruition of the NORTH AMERICAN UNION.

"The USMCA has a total of 34 chapters, 12 more than the original NAFTA, which had only 22 chapters. Unlike the 1994 NAFTA, the USMCA includes chapters on labor, environment, anticorruption, regulatory policy, competitiveness, and Mexico's exclusive ownership of its gasoline and natural gas resources, among others."

The last part of the above paragraph raises some very serious questions, two of which have been pointed out by Arthur Thompson, CEO of the John Birch Society...

- 1. Why is it necessary to spell out the fact that Mexico retains exclusive ownership of its gas and natural gas unless they are worried about international controls or an eventual North American merger?
- 2. Why Mexico and not Canada or the United States?

Mr. Thompson continues by stating that the first question one has to ask is why are socialist Canada and corrupt Mexico (led by a very pro-communist president) happy to sign this deal?

Because they are playing their part in aiding the agenda for the new world order, i.e., world government to use the trade agreement strategy to incrementally and gradually combine all of North and South America into one regional entity. They would be happy to sign, for they know that the agenda's plan is to successfully combine all separate nations into regional entities of their areas. Then they follow up with combining all regional entities into one global entity with global authority.

This is likely the reason Mexico chose to have it spelled out that it would retain exclusive ownership of its gas and natural gas. They could avoid sharing with the U.S. or Canada if the North American Union successfully comes to fruition as planned.

### Trade Representative Robert Lighthizer

Why didn't our trade representative, Mr. Lighthizer, get the same agreement for America? He simply could have had it entered into the text of the agreement affording America the exclusive ownership of all its mineral properties.

If Mr. Lighthizer is on our side and protecting our interests, surely that is something he would arrange for our benefit and protection, but he did not. This raises the question — **is he on our side? No! Absolutely not.** I say this because of where he comes from, who he is connected with, and their objectives.

What Lighthizer and others are up to is the destruction of the sovereignty of all nations and the amalgamation of all of them into one entity of global governance, i.e., the new world order, or one world government — Novus Ordo Seclorum (A new order of the ages).

### **Council on Foreign Relations**

Mr. Lighthizer is a member of the globalist Council on Foreign Relations (CFR) and as such he would conduct his activities to bring to fruition the goals and objectives of the CFR.

# The Revised NAFTA Trap And American Sovereignty

According to the New American article of Monday, October 1<sup>st</sup>, NAFTA "Finessed" to Include Canada at the Expense of U.S. Sovereignty by Bob Adelmann, the United States is about to be sucked into a trap with the new NAFTA deal that could lead to a loss of sovereignty.

#### Trump Loses on Chapter 19

"Last Friday, the liberal *Toronto Star* first leaked about the coming "finesse": "The dispute resolution impasse [over sovereignty-threatening Chapter 19 in the original NAFTA] could be finessed." (Emphasis Added) (Bold type mine)

Chapter 19 allows Canada, Mexico and the United States to challenge one another's anti-dumping and countervailing duties

in front of a panel of representatives from each country. Over the years, Canada has successfully used Chapter 19 to challenge the United States on its softwood lumber restrictions.

In a recent article in the Wall Street Journal, they confirmed that the United States could fold in order to keep Canada in the deal by noting that "there are still ways to *finesse* deadlines and processes before NAFTA 2.0 ultimately takes effect." (Emphasis added)

Just before midnight Sunday, another writer at the Wall Street Journal wrote that Trump's demand to eliminate Chapter 19 altogether from the United States Mexico Canada Agreement (USMCA) disappeared entirely under pressure from those who wanted to keep it.

#### Trans Pacific Partnership Redux

My take on this is that someone had to have blatantly disobeyed President Trump's demand for Chapter 19 to be eliminated; we don't know if it was only one person, or if there were others involved in causing the President's demand to **entirely disappear**. We do know however that there are many, even in the Trump administration, who reportedly favor trade deals both now and in the past such as the Trans Pacific Partnership (TPP). According to former Senator Sessions these deals would have resulted in open borders and unlimited immigration. There was also a provision which allowed for future additions to be added. Another provision stated there were other provisions that would not be revealed for at least four years after the TPP was ratified and went into effect. How sinister is that?

The bulk of the TPP was 42 inches high and was composed of 30 chapters with an average thickness of 1.4 inches. There were only five chapters or about seven inches that were about trade. The remaining 25 chapters consisting of about 35 inches

were about how our country would have to be changed. Obama had stated that some of our laws had to be changed to coincide with the laws of the other countries making up the TPP.

It is obvious that based on what little we know that there were many sinister and traitorous plans for us in that 35 inches of the TPP text which had nothing to do with trade.

It is difficult to imagine that there were and are many powerful and respected people in our nation and our government who are involved in the treason which appears to be on a rampage, yet they continue to be lauded and applauded by those we consider to be the opinion molders of society.

The President's demand that Chapter 19 be eliminated completely disappeared entirely under pressure from those who wanted to keep it. The Wall Street Journal article noted that:

A broad coalition of Republican and Democratic members of Congress, joined by leaders from American business and labor organizations have made clear in recent days they would be unlikely to support a revised NAFTA that doesn't include Canada.

In response, Trump officials, including globalist Robert Lighthizer as Trump's trade representative and Trump's son-in-law, Jared Kushner said various sources "brokered the deal" then suggested they would try to find ways to finesse the procedures and deadlines to leave the door open for Ottawa to be part of NAFTA 2.0 before an agreement was submitted to Congress for consideration. (Italics Mine)

Back to the New American's article:

"Merriam Webster defines "finesse" as "a skillful handling of a situation, an adroit maneuvering." Merriam Webster could have added "utter collapse of previous nonnegotiable demands covered up with pronouncements to the contrary in order to get a deal done." And an utter collapse it was, as the Wall Street Journal noted in its coverage early Monday morning, "The United States compromised by dropping its demands to scrap the original treaty's Chapter 19 provisions (creating) the special NAFTA courts allowing member states to challenge trade restrictions imposed by the others."

The New American article states, "This was no compromise. It was an utter collapse — a treacherous sellout of precious sovereignty in order to keep Canada in NAFTA 2.0 The Journal's writers covering the "finesse" of American interests in favor of supporting globalism tried to handle the collapse "adroitly."

Trump officials argued such courts infringed American sovereignty, but Canada sees the panels (supra-national courts operating under Chapter 19 that essentially allow **unelected bureaucrats** to bypass America's Constitution) as vital to protecting its industries against what officials consider frequent improper tariffs imposed by the U.S. — concerns heightened by the Trump administration's aggressive moves to block a range of Canadian exports from lumber to aircraft.

One must remember that unelected bureaucrats cannot be gotten rid of, and this has always been a communist tactic. Deals with unelected people in charge should immediately be destroyed.

There's the treachery...giving up essential constitutional guarantees with long-term negative implications for national sovereignty in order to cut a deal with socialists in Canada and Mexico. This includes supporters inside the Trump administration who cherish a global community (world government) in place of sovereign nations making their own enforceable decisions according to the will of their people. (Bold type mine)

There are other parts to the USMCA related to demands that

auto makers make sure that much of those vehicles are built by high-paid workers and that unions gain substantial inroads into Mexican industry, all in the name of fairness and equity. But these fade in importance when compared to the retention of the odious Chapter 19.

#### Stopping NAFTA 2.0

There remains an opportunity to stop NAFTA 2.0, noted the Wall Street Journal.

The official up-beat rhetoric is lauding and applauding the deal as something great, and according to the article in the New American (President Trump called USMCA a "wonderful new trade deal" for all three countries) much work remains before a new NAFTA takes effect. The agreement must win ratification by the U.S. Congress, where trade deals have become increasingly difficult to pass.

Administration officials said they don't expect the new NAFTA 2.0 pact to face a Congressional vote until next year, when the House may be under control of Trump-hostile Democrats reluctant to support any of the president's initiatives.

This gives more time for activists who see the sovereignty-threatening dangers of keeping Chapter 19 in NAFTA 2.0 to create awareness among their peers and pressure their elected representatives in Congress to vote against it.

Bob Adelmann made the final comment, "It's not a 'wonderful new Trade Deal,' Mr. President, but the same old wolf all dressed up in new clothing. You gave away your trump card in order to cut this deal. Shame on you." (Bold type mine)

I heartily agree. If the President allows Chapter 19 to stand in this new NAFTA 2.0 it will bring shame on his reputation at some time in the future for the simple reason that it will be perceived as a promise he didn't keep. And more than that it will be seen and remembered as just another event where the

leadership of this nation allowed the globalist enemies to incrementally chip away at our sovereignty and thus — at our independence and liberty.

#### Treasonous Actions Against President Trump

Now comes word that the USMCA agreement is much worse than the NAFTA which President Trump promised to replace.

According to Christian Gomez's New American article, <u>USMCA: A NAFTA Reboot?</u>, this new agreement by U.S. Trade Representative and Council on Foreign Relations member Robert Lighthizer is "built on" many aspects of the TPP, which according to the New American writer, have the potential to strip the U.S. of its sovereignty.

There are many features in the USMCA agreement that pose a grave danger to the liberty and independence of the American people. And it was all to be expected considering how the Trump administration had become saturated with traitors who are there to stop the Trump agenda for a better America.

In <u>part one of this series</u> I mentioned a quote by the poet Robert Frost in which he said, "There were many roads emerging from the wood, but we took the one less traveled; and it has made all the difference."

#### **Choices Have Consequences**

Frost's quote presents an immutable principle which is, "All choices result in consequences." This is something that needs to be instilled in every child from birth to protect it from itself, and also the world.

This is something I learned about in bits and pieces through experience over a period of forty, or maybe fifty years; not completely coming to the realization that this is an immutable principle that holds when choices are made and followed up with action, then the consequences are deliberate. They're going to happen — no way to avoid them.

This applies to both negative choices and positive ones. When we make a positive choice in life, and commit to a definite follow-up then the odds are that a positive result will follow. However, if we make wrong choices and follow-up with action to bring them to success, then it is a given that the results will be in consequences relating to the choices.

In <u>Romans 1</u>, the apostle Paul presents to us some revelations concerning those that make wrong choices, either of not submitting to God and his ways, or of choosing to become completely anti-God and being at war with him as well as all those who accept him and his principles.

There are those who might contend that the reason for this is because the people Paul is speaking of simply don't know anything about God and his ways, or if he even exists, but let's look at Romans 1:18-20.

For the wrath of God is revealed from heaven against all ungodliness and unrighteous of men, who hold the truth in unrighteous. (Hold back the truth)

Because that which may be known of God is manifest in them; for God hath shewed it unto them.

For the invisible things; of him from the creation of the world are clearly seen, being understood by the things that are made, even his eternal power and Godhead; so that they are without excuse:

Continuing in verse 21.

Because that, when they knew God, they glorified him not as God, neither were thankful, but became vain in their imaginations, and their foolish heart was darkened.

- 22 Professing themselves to be wise, they became fools,
- 23 And changed the glory of the uncorruptible God into an image made like to corruptible man, and to birds and fourfooted beasts, and creeping things.

Now we come to the part where the consequences begin to kick in; the next verse states,

Wherefore God also gave them up to uncleanness through the lust of their own hearts, to dishonor their own bodies between themselves.

and in verse 25,

Who changed the truth of God into a lie, and worshiped and served the creature more than the Creator.

In view of what Paul has stated, it becomes clear that we can entirely dismiss the idea that the people Paul was speaking about were completely ignorant of God and his existence.

Because that which may be known of God is manifest in them;

for God hath shewed it unto them...so that they are without excuse.

It is impossible to be against something which in one's mind doesn't exist and many of those who reject God are in complete rejection of God's very existence. Yet they continue to actively oppose Him in everything.

#### Manmade Laws

Let's take the abortion issue, the proponents of which continue to contend that the unborn child is nothing more than a glob of flesh, and therefore, it is not a person so it is not murder to dispose of it. But what does God say about that?

Exodus 21 - 22 has this to say on the subject:

If men strive, and hurt a woman with child, so that her fruit depart from her, and yet no mischief follow: he shall be surely punished, according as the woman's husband will lay upon him; and he shall pay as the judges determine.

And verse 23 continues with,

And if any mischief follow, then thou shalt give life for life.

God's Words make it completely clear that this is an unborn child and this is true to anyone with a sane mind. However, we have to remember that we are dealing with people who have been turned over by God to a reprobate mind, otherwise they would not be seeing things as they do. So, they do not have a sane mind to think with. Not only that, but they do not even have reference point to start with in trying to discern right from wrong. Thus, the reprobate mind is incapable and completely out of character for logical thinking regarding right and wrong.

Back to verse 21

Because that, when they knew God, they glorified him not as God, neither were thankful; but became vain in their imaginations, and their foolish heart was darkened.

So, as we see here, after knowing God, and refusing to glorify him for whom he was, for the simple reason that they had become conceited in their imaginations, possibly perceiving themselves to be equal with, if not superior to God, then their foolish heart was darkened. And, professing themselves to be wise, they became fools.

Romans 1:24 states

Wherefore God also gave them up to uncleanness through the lusts of their own hearts, to dishonor their own bodies between themselves.

Romans 1:26 says

For this cause God gave them up unto vile affections: for even their women did change the natural use (of their bodies) into that which is against nature. (Italics mine)

Lev. 18:22

Thou shall not lie with mankind as with womankind.

Continuing into verse 27:

And likewise also the men, leaving the natural use of the women, burned in their lust one toward another; men with men working that which is unseemly, and receiving in themselves that recompence (reward) of their error which was meet. (Italics mine)

And additionally, Eph. 5:12

For it is a shame even to speak of those things which are done of them in secret.

And here I can't help thinking of some of our Supreme Court

Justices, and what they contend with and support as law, regardless of the scriptural evidence to the contrary. All rights come from God and nowhere else; and certainly not from an anti-God government. So, if all rights come from God, and they do, then it necessarily follows that all authority comes from the same source. Therefore, all law, or what is said to be law, in order to be what it is said to be must necessarily be backed by Gods authority, or otherwise it is not law, but only force.

It is fully evident to me that to only glance through and note the high spots of Romans 1, without mentioning many other biblical references for those making laws which give rights, i.e., license, to a segment of the population and abrogating that which is according to God's word, is an abomination to Him and is completely unthinkable to anyone with a sane mind.

Again, we have to remember that these are people who have been turned over by God to a reprobate mind. Therefore, they are incapable of thinking sanely about things relating to God and his ways.

As a prime example of this, let's review the decision by the Supreme Court on the gay marriage issue.

According to an article in News with Views Justice Kennedy, writing the majority decision said, "Under the Due Process Clause of the Fourteenth Amendment, no State shall deprive any person of life, liberty, or property, without due process of law. The fundamental liberties protected by this Clause include most of the rights enumerated in the Bill of Rights."

It appears that this was the authority upon which the Court found that "gay people" have a fundamental right to marriage; this is what Justice Kennedy stated in the writing of the majority opinion. Did he not know that by calling it a fundamental right is a veiled assertion that this right comes from God?

How could anyone with a sane mind perceive that the right for "gay people" to marry is authorized and enumerated in the Due Process Clause of the Fourteenth Amendment? At the time when the Fourteenth Amendment became a part of the Constitution there had been no thoughts concerning the possibility of "gay people" having the right to marry. So how could it have been enumerated in the Bill of Rights? It couldn't have.

This is what those of the satanic agenda for world government do. It is an integral part of their method of operation, (modus operandi) which they are committed to. They will state something which is, or equates with a supposition, i.e., thought to be some part of the Constitution and use this as authority for whatever they are trying to establish as being a legitimate part of the law.

And here again, we find that Justice Kennedy has implicitly asserted that something exists which doesn't, the fundamental right of "gay people" to marry. But there's nothing new about this, it's what they do.

There is much more to be said on this subject of how the influence of people like those discussed by Paul in Romans 1 plays out into society in ways that result in millions of people, especially children through the foster care program being consigned to hell.

## Blessed Is The Man Who Walks In The Council Of God, Part 1

Blessed is the man that walketh not in the counsel of the ungodly, nor standeth in the way of sinners, nor sitteth in the seat of the scornful. But his delight is in the law of the Lord; and in his law doth he meditate day and night. And he shall be like a tree planted by the rivers of water, that bringeth forth his fruit in his season; his leaf also shall not wither; and whatsoever he doeth shall prosper. The ungodly are not so: but are like the chaff which the wind driveth away. Therefore, the ungodly shall not stand in the judgment, nor sinners in the congregation of the righteous. For the Lord knoweth the way of the righteous: but the way of the ungodly shall perish. —Psalm 1:1-6

Upon being confronted with this for the first time one might ask why one could be blessed by simply avoiding those who occupy the categories of the ungodly, sinners, and the scorners.

By avoiding these people, we might say that one's blessings begin simply by separating themselves from objects of contamination. My Dad would occasionally admonish me to be careful who I chose as my associates for, as he put it — we are known by the company we keep, as well as the company we don't keep.

Simply staying away from the ungodly, the sinners and scorners will result in a person not beginning to think like they do, for as a man thinketh so is he.

Now let's dig a little deeper and see if there aren't additional reasons stated in Psalm 1 for someone to be blessed.

In verse 2 we find, but his delight is in the law of the Lord; and in his law doth he meditate day and night.

That just about says it all, doesn't it? If a young person, or anyone begins, or changes their life-style by staying shy of the wrong crowd and digs into the gospel of Christ and follows up by accepting Him as personal savior and then gets involved in meditating on God's word, not just occasionally, but daily, then that will be the icing on the cake. This is a practice that will keep one on track to "Becoming like a tree planted by the rivers of water, that bringeth forth his fruit in his season; his leaf also shall not wither; and whatsoever he doeth shall prosper." (Psalm 1:3)

But now, what about the ungodly? According to the remainder of psalm 1, and on into psalm 2, there is a radical change about how things will play-out for those who reject God and His ways.

In reference to psalm 1:4, the next verse says, "The ungodly are not so: but are like the chaff which the wind driveth away...And in addition to not being blessed by God, comes the awful separation, the putting aside — away from the righteous. For verse 5 points out that they, the ungodly, shall not stand in the judgment with the congregation of the righteous. Then continuing on with verse 6, For the Lord knoweth the way of the righteous: but the way of the ungodly shall perish.

The ungodly are going to be separated and shall not stand in the judgment with the righteous, so then where will they be separated to? Of course, it can't be anywhere else but what is referred to as the **Great White Throne Judgment**. At this gathering there will only be those who are accursed, have already been dammed because they have continued to reject God by not accepting Christ who died for their sins. Why do the people rage, and imagine a vain thing?

The kings of the earth set themselves, and the rulers take council together, against the Lord and against his anointed, saying, Let us break their bands asunder, and cast away their cords from us.

This is something these ungodly or anti-God people, both then and now, have been involved in for many centuries, going all the way back to the days of Nimrod. Later there were the enlightened ones, the Illuminati, from which came the <u>Jacobins</u> resulting in the <u>French Revolution</u>; in which <u>Robespierre</u> concocted a scheme concerning something called the <u>Department of Public Safety</u>. Blessed are all they that put their trust in him.

Yet have I set my king upon my holy hill of Zion. I will declare the decree: the Lord hath said unto me, Thou art my Son; this day have I begotten thee.

Ask of me, and I shall give thee the heathen for thine inheritance, and the uttermost parts of the earth for thy possession.

Thou shall break them with a rod of iron; thou shall dash them in pieces like a potter's vessel.

Be wise now therefore, 0 ye kings: be instructed, ye judges of

the earth. Serve the Lord with fear and rejoice with trembling.

Kiss the Son, lest he be angry, and ye perish from the way, when his wrath is kindled but a little. Blessed are all they that put their trust in him.

At this point God is warning the kings and rulers, as well as the judges, who have conspired against the Lord and his anointed, of the danger of kindling the anger of the Son, who is Jesus, only a little, for there could be dire consequences to follow.

Ah! But did the kings and judges take heed of the warning? Of course not, evidently they must have been inebriated with their power and self-importance; they figured they could give God his comeuppance.

crowns; and he had a name written, that no man knew, but he himself.

- <sup>13</sup> And he was clothed with a vesture dipped in blood: and his name is called The Word of God.
- <sup>14</sup> And the armies which were in heaven followed him upon white horses, clothed in fine linen, white and clean.
- <sup>15</sup> And out of his mouth goeth a sharp sword, that with it he should smite the nations: and he shall rule them with a rod of iron: and he treadeth the winepress of the fierceness and wrath of Almighty God.

And in verse 19-21 it says,  $^{19}$  And I saw the beast, and the kings of the earth, and their armies, gathered together to make war against him that sat on the horse, and against his army.

- <sup>20</sup> And the beast was taken, and with him the false prophet that wrought miracles before him, with which he deceived them that had received the mark of the beast, and them that worshipped his image. These both were cast alive into a lake of fire burning with brimstone.
- <sup>21</sup> And the remnant were slain with the sword of him that sat upon the horse, which sword proceeded out of his mouth: and all the fowls were filled with their flesh.

What I have written is a partial account of what happens to someone who makes the wrong choices. And as we take note of what is going on in today's world we can readily see that the day when God unleashes his wrath is looming ever so much closer to us. They designed separated institutions that cannot be unified by mechanical linkages, frail bridges, tinkering. If we are to 'turn the founders upside down' — to put together what they put asunder — we must directly confront the constitutional structure they erected." (Bold type mine)

Burns also served on the board of yet another bicentennial group, the <u>Committee on the Constitutional System</u> (CCS). As of January 1987, the CCS had forty-eight board directors, more than a third of them members of the Council on Foreign Relations. According to Perloff, the CCS (then) were proposing drastic changes in the Constitution one would be that Congress would be expanded. The party whose nominee became president would designate one-sixth of all representatives in the house and one-third of all the senators. This would diminish the elective power of the voters and the balance between the executive and the legislative spheres. Also, the requirement for Senate ratification of treaties would be lowered.

In "<u>Reforming American Government</u>," which was put together by this same Committee on the Constitutional System, we read:

"The change will require major surgery. One cannot stop short of bold and decisive departures. And yet a guiding principle should be to write the new Constitution in a way that permits considerable leeway." (Bold type mine)

How about that, huh? One can see that their plan is to put together a constitution that would allow the left to go just about anywhere they decided to go; especially with so many traitorous judges running interference for them.

## Beware Of A Renegotiated NAFTA, Part 2

<u>In part one</u>, I pointed out several dangers which I considered to be innately lurking in what would come forth in the renegotiating of the proposed "free trade" agreement — NAFTA, but there were many more which I was unable to cover. Therefore, let's look at some of what I left out.

#### NAFTA, Economics or Liberty

Listening to the President's recent speech to the Farm Bureau

in Nashville, Tennessee, I was quite encouraged by his recounting of all the accomplishments of his administration in his first year. However, at one point I became somewhat apprehensive when he spoke of NAFTA. He made the statement that we are renegotiating NAFTA to make sure that our workers and businesses get a fair deal.

The question arises, if he is only looking at NAFTA from the standpoint of economics, what would be fair for workers and business? What about our sovereignty, our independence, in short — our total liberty? On the basis of all we have seen posted, this is something which has not been mentioned. And it makes me very suspicious, it worries me that any mention of the possibility of loss of American sovereignty is purposely being avoided. Not only is it being avoided, but even more sinister than that, I suspect that our trade representatives, especially Mr. Robert Lighthizer who is a member of the Council on Foreign Relations (CFR), is managing the negotiations in a way that keeps sovereignty out of the dialogue.

#### Trade Deals, Global Governance and Regionalism

As noted in part one, we all had hopes that President Trump's pulling out of the TPP was a precursor to what lay ahead relative to all of the so-called trade deals. Yet, he has surrounded himself, either knowingly or otherwise, with those whose agendas are the complete antithesis of his own. Therefore, once again, the CFR emerges in the person of Robert Lighthizer, the veteran trade negotiator.

Let's look at a bit of the background. The initial attempt of the globalist insiders to put into motion an international apparatus to result in what is referred to as the "new world order," was the <u>League of Nations</u>. However, since the United States Senate was allowed to read the proposal, it was rejected; and this resulted in these Conspirators for a World Government having to start from scratch to form a new entity

John Foster Dulles had been one of Woodrow Wilson's (Federal Reserve and Income tax) young proteges at the 1919 <u>Paris Peace Conference</u>. A founding member of the CFR...he was an in-law of

the Rockefellers, Chairman of the Board of the Rockefeller Foundation, and Board Chairman of the Carnegie Endowment for International Peace.

Now, why do I single-out Dulles as a possible ready-made founder of the new entity which was to become the Council on Foreign Relations (CFR)? Because Dulles was already a part of what we now refer to as the establishment, or in current vernacular, The Swamp, i.e., the forces which coordinate the agenda for world government.

One example of the propaganda of the insiders is a quote of Mr. Dulles from a speech he delivered in 1952 before a meeting of the Louisville Bar Association.

"Treaties make international law and also, they make domestic law. Under our constitution, treaties become the supreme law of the land...treaties, for example, can take powers away from the Congress and give them to the President; they can take powers from the states and give them to the Federal Government or to some international body, and they can cut across the rights given the people by their constitutional bill of rights."

This was the mind-set that was being promoted by the forces of globalism so as to prepare and condition people to accept the lie that was a key part of their agenda as the truth. here at the policy making level have had experience, either in <u>OSS</u> (Office of Strategic Services) or the <u>European Economic Administration</u>, with directives from the White House. We operate under those directives here; would you like to know what those directives are?" Dodd replied that he would. Gaither said: "The substance of them is that we shall use our grant-making power so to alter our life in the



United States that we can be comfortably merged with the Soviet Union."

These directives, spoken of by the president of the Ford Foundation, were coming from the White House. And who was in the White House? It was one our most celebrated heroes of WWII, Dwight D. Eisenhower. Years ago the Ford Foundation, at a cost of \$25 million over 10 years, wrote the <a href="frightening New States Constitution">frightening New States Constitution</a> which eliminates God given rights from our founders' Constitution and it is waiting in the wings for another Constitutional Convention.

#### Recruited by Globalists

No doubt Eisenhower had been recruited by the globalists to prevent true conservative Senator Taft from becoming the Republican nominee. What about that remaining 35 inches? It was about how our country and our laws would have to be changed, and how much of our liberties we would have to give up.

According to then Senator Sessions, it would result in open borders along with unlimited immigration. In addition, there was a provision which stated that all of the provisions would not be disclosed for at least 4 years after it was ratified and came into effect, and another caveat which stated other provisions could be added as it became necessary.

None of this is supposition, it's the exact modus operandithey'll use.

# The path to understanding Pt. 13

# The long-view, what's in store going forward

This is the uppermost concern in the minds of millions of Americans at the present time...what's in store going forward?

I will attempt, through a few different scenarios, to shed a little light on what we could possibly be confronted with as we proceed down the road into 2017 and beyond.

First case scenario would be for Hillary to be elected

president. If that were to happen everything would continue on as it has throughout the Obama regime.

However, it is practically a given that there would be a concerted, (coupled with a completely coordinated effort to accelerate the pace, i.e.), attempt to speed up the process. However, since Cruz is perceived to be conservative, and an "Outsider," this no doubt resulted in some conservatives, who were not too enamored with Trump, to choose Cruz because he presented himself more to their liking. Then there were those like Rush Limbaugh, who maintained that Cruz was the real Conservative — not Trump. Of course, esoterically speaking, Limbaugh's claim that Cruz was a real Conservative, was true; simply for the reason that he, Cruz, is committed to keeping the Establishment's agenda on track. This means that he is in support of Obama's so-called "Free Trade", which would reduce our sovereignty to almost nothing. In addition, Senator Sessions, of Alabama has revealed that there is a provision in the Trans-Pacific Partnership (TPP) that states that there are certain provisions in the agreement that will not be revealed for at least four years after it goes into effect. Also embedded in it is the authority to add other provisions in the future as needed. Remember, Cruz voted to give fast tracking of this TPP to Obama. Do you know what that does?

Here's what Sen. Jeff Sessions says about Fast Track and the

TPP. According to Sessions: "The predictable and surely desired result of the TPP is to put greater distance between the governed and those who govern. It puts those who make the rules out of reach of those who live under them, empowering unelected regulators who cannot be recalled or voted out of office. In turn, it diminishes the power of the people's bulwark: their constitutionally-formed Congress." Shocking, this is what this phony Christian (Cruz) supports. [Link]

#### From Breitbart comes this:

"TPA eliminates Congress' ability to amend or debate trade implementing legislation and guarantees an up-or-down vote on a far-reaching international agreement before that agreement has received any public review," Sessions writes. "Not only will Congress have given up the 67-vote threshold for a treaty and the 60-vote threshold for important legislation, but will have even given up the opportunity for amendment and the committee review process that both ensure member participation. Crucially, this applies not only to the Trans-Pacific Partnership (TPP) but all international trade agreements during the life of the TPA.

"There is no real check on the expiration of fast-track authority: if Congress does not affirmatively refuse to reauthorize TPA at the end of the defined authorization (2018), the authority is automatically renewed for an additional three years so long as the President requests the extension.

"And if a trade deal (not just TPP but any trade deal) is submitted to Congress that members believe does not fulfill, or that directly violates, the TPA recommendations—or any laws of the United States—it is exceptionally difficult for lawmakers to seek legislative redress or remove it from the fast track, as the exit ramp is under the exclusive control of the revenue and Rules committees."

In addition to those concerns about how the deal would not in fact empower Congress—it would instead weaken Congress—Sessions notes that Obama or any future president could redact or classify information from a report the president would be required submit to Congress to get fast-track trade approval if TPA is adopted.

"Moreover, while the President is required to submit a report to Congress on the terms of a trade agreement at least 60 days before submitting implementing legislation, the President can classify or otherwise redact information from this report, limiting its value to Congress," Sessions writes. "Is TPA designed to protect congressional responsibilities, or to limit Congress' ability to do its duty?"

The second major point in the Sessions document details how passing TPA through Congress would result in "increased trade deficits."

"Barclays estimates that during the first quarter of this year, the overall U.S. trade deficit will reduce economic growth by .2 percent," Sessions writes. "History suggests that trade deals set into motion under the 6-year life of TPA could exacerbate our trade imbalance, acting as an impediment to both GDP and wage growth. Labor economist Clyde Prestowitz attributes 60 percent of the U.S.' 5.7 million manufacturing jobs lost over the last decade to import-driven trade imbalances."

Sessions also cites former AT&T CEO Leo Hindery, Jr., who wrote in a recent column for Reuters that since the North American Free Trade Agreement (NAFTA) and South Korea free trade agreements were passed and implemented, "U.S. trade deficits, which drag down economic growth, have soared more than 430 percent with our free-trade partners."

"In the same period, they've declined 11 percent with countries that are not free-trade partners," Hindery wrote, in

the part where Sessions cites him, adding: "Obama's 2011 trade deal with South Korea, which serves as the template for the new Trans-Pacific Partnership, has resulted in a 50 percent jump in the U.S. trade deficit with South Korea in its first two years. This equates to 50,000 U.S. jobs lost. "

All of the above is practically a given with any of the contenders becoming successful in attaining the office of President, other than Trump. This does not mean that Trump would be able to prevent it from happening, simply for the reason that the leadership in both the House and the Senate, along with the total control apparatus of the left, is committed to the plan, the plan of the Insider hierarchy, claimed by Obama as his plan to Fundamentally Transform America. However, it (The Plan) has been in the works long before he came into existence, he is only the baton carrier for the current segment of its fruition.

All of the above, in my opinion, is what we could look forward to if Cruz is elected. Continuing on she states, "For all his allure as an outsider, Canada-born Ted Cruz is in fact an insider playing a role similar to the one Barack Obama played back in 2008 when his handlers portrayed him as the hope and change candidate out of nowhere. Ted Cruz set out to be an elitist from the very beginning."

Then there's the following according to Jason Zengerle's piece in GQ Magazine, "As a law student at Harvard, he refused to study with anyone who hadn't been an undergrad at Harvard, Princeton, or Yale. Says Damon Watson, one of Cruz's lawschool room-mates. "He said he didn't want anybody from 'minor ivies' like Penn or Brown."

Based upon this revelation, he is endowed with other characteristics, and or attributes. This could be a subdued, covert arrogance in addition to a super ego.

Much can be discerned about Cruz's character by checking out those with whom he is in connection with, and especially his list of doners:

According to Kevin "Coach" Collins, Ted Cruz maybe "just following the rules the same as everybody else" but that is just the problem. Ted Cruz is following the rules the same as everybody else in the phony rightwing neo-cons.

Goldman Sachs, the company his wife works for, which is the quintessential "Wolf of Wall Street" and an ATM for Democrats, gave Cruz \$69,350. They also gave at least \$10,000 to both Nancy Pelosi and Steve Israel. They don't donate to those they don't see as team players. Don't forget their low interest loan to Ted and Heidi when he ran for the Senate of Texas.

The pro-amnesty Club for Growth gave Cruz \$705,000 and spent another \$1 million independently in Iowa to support amnesty.
