# Constitutional Concealed Carry Reciprocity

They claim to respect the Second Amendment, but would deny citizens of other states their right to keep and bear arms while in their state. That doesn't support the Second Amendment. They claim to respect the rights of lawful and responsible gun ownership, but not for citizens of others states. That violates the Fourteenth Amendment.

#### **Presidential Tariffs**

Due to IEEPA tariffs, President Trump has negotiated agreements worth trillions of dollars with major trading partners, including most recently China. Unwinding those agreements, he warns, would expose us to ruthless trade retaliation by far more aggressive countries and drive America from strength to failure, with ruinous economic and national security consequences.

# Medical Freedom or Government Overreach?

In response to the COVID-19 vaccine mandates, several states passed legislation to put a halt to such practices. For example Idaho recently passed the Medical Freedom Act. The

question is, does this legislation protect medical freedom or is it just another example of government overreach?

### Free Speech or Free Beer

When government tells you what you can do with your property, your property rights are diminished. When people claim a right to education, healthcare, or any other commodity, your right to yourself, your liberty and, of course, your property rights, are destroyed. Even the right to keep and bear arms becomes abusive when it deprives someone of the right to control their property.

## Searching Without a Warrant

In general, the police need a warrant to enter your home without your permission, however there are exceptions to the warrant requirements. The Fourth Amendment protects you from unreasonable searches, not warrantless searches. The case Case v. Montana is about what makes police entry into a private home reasonable.

# Colorado Conversion Therapy Oral Arguments

Rather than protecting children from harm, this law prevents minors from getting the treatment that 90% of them need. The evidence that "conversion therapy" is harmful is questionable at best and medical malpractice at worst. I wonder what would have happened if Ms. Chiles' legal team had studied the Constitution rather than constitutional law?

Again, no case in history supports that theory. Vanderstok, where Mr. Vanderstok challenged the recent regulation from the Bureau of Alcohol, Tobacco, Firearms, and Explosives redefining weapons parts kits as firearms. It seems the Supreme Court has a hard time reading either the law or the Constitution.

## Whose Safety Matters More?

More disturbing is the fact that a District Court judge either cannot read plain English or doesn't care about their oath of office. Sure, Arkansas can appeal the judges decision to the Circuit Court, and that might be the safer answer, but is it the most just answer?

In the case Garland v. VanDerStok, the issue seems to come down not just to what the definition of a firearm is, but who gets to decide. What seemed to be forgotten in the oral arguments is the fact that an 'arm' by any other name, is still protected by the Second Amendment.

# San Francisco v. EPA — Oral Arguments

How California handles its water quality is their business. Placing a federal agency in the middle does nothing but add more bureaucracy to an already bureaucratic nightmare. Maybe that's why the framers limited Congress to only making laws necessary and proper for executing the powers vested by the Constitution in the government of the United States.

If we allow them to be trampled because of tradition, we lose more than just the right to a trial by jury, we lose the most basic protections of justice.

I do have a concern. Now that the courts are expected to infer what Congress meant when it was silent or ambiguous, we have a similar problem, just with another branch of government.
