transsexual identities. The teaching will come under ‘Relationship Studies’ and would be a mandatory part of the school curriculum, instead of ‘Sex Education’, from which parents can presently opt their children out of.

Recently, it was reported that up to 600 parents in Birmingham, UK, kept their children from school in a demonstration against relationship studies and a programme



called 'No Outsiders' There was an emphasis on the demonstrators being 'Muslim'. However, concerned parents across the country have been petitioning the Lords Committee expressing their alarm at the deceptive legislation which will remove the parent's choice for their child's education in nursery school.

Kenan Malik, an Observer columnist in an article printed in the Guardian attacked two issues with just one stone by labelling the demonstration as bigoted and likening it to a Tommy Robinson event spewing hatred, except it was Muslim parents spewing hatred towards gay relationships!

Whilst there is a very obvious pushback taking place within our schools against the indoctrination and the mandatory teaching of gender issues as being lifestyles to very young children, unfortunately there are now a few other new kids on the block waiting to join forces, which are subtly and not so modestly intent on mutilating the truly natural potential of creation.

### **Do you have Gymnophobia**

Next month, families in the UK, are being invited again to a nude family fun event at Waterworld Aqua Park, Stoke on Trent. The British Naturist Society who have advertised their event as being open to members and non members, and to all

adults and children of any age are charging £21 for adult non members, £5 for children. Under fives go free.

Whilst petitions against the events are also taking place around the country at similar venues, in relation to exposing children to adult nudity, the British Naturist Society who claim that they take their safeguarding and health and safety precautions seriously, still advertise that they exist to unite and support naturists, to protect naturist places and make social nudity more acceptable across the UK.

But naturist family events at public leisure centres are not the only places where nudity is becoming socially acceptable.

The [infamous Channel 4 network in the UK](#) which often crosses the boundaries of decency have been airing 'literally', a dating programme called Naked Attraction, where people looking for love choose their date not by viewing their face or getting to know the personality of someone they may be attracted to; but by choosing a partner from how they look in their 'birthday suit'. The programme is at least honest if not shallow, in contrast to naturists who claim they are more interested in each others minds, rather than the obvious nudity of the strangers they may mix with.

In 2017, [Paris also opened its first ever naked restaurant](#) called 'Au Naturel' indicating that the drive by Naturist societies to make nudity more acceptable in the mainstream is 'happening'.

Another popular Channel 4 TV programme which also crosses the boundaries of decency is The Sex Clinic where young and 'active' people are filmed being intimately investigated for transmitted sexual diseases. The trailers to the programme are presented in a light hearted way in bright colourful clinics with attractive doctors. The most recent episode was advertised as:

*"Emily requests an STI test to make sure her hook-up isn't*

*cheating. Leticia seeks advice on bipolar and sex. And a male stripper has a rash down below"*[\[Link\]](#)

Dr Naomi Sutton, known as Dr Naomi in the programme hopes to de-stigmatise attitudes towards sexual health and promote healthier attitudes; but whilst her work as a Consultant Physician in Integrated Sexual Health at The Rotherham NHS Foundation Trust is valuable in helping under 16's, trafficked women and victims of sexual assault, one cannot help but wonder what happened to the healthier attitudes we once highly held before sexual behaviour was de-stigmatised and anything goes attitude replaced them, leading to the increase in sexually transmitted diseases which medicine now has to treat. It is reported that the sexual health crisis in the UK with syphilis and gonorrhoea on the increase, is all due to government funding being withdrawn year upon year towards funding sexual health services.

National Aids Trust chief executive Deborah Gold added

*"This government is presiding over a national crisis in sexual health, caused in large part by the decision to implement year-on-year cuts to the public health grant which funds sexual health services," The impact of these cuts is being felt disproportionately by people in black and minority ethnicity (BME) communities, young people, and men who have sex with men – a group which accounts for 78 per cent of the new syphilis cases.*

Marketers of course know that the successful selling of any product is always reliant on the visuals. With the dark web becoming more accessible to younger people and with a reported

30,000 cases reported in the UK over the last 4 years of children carrying out sexual assaults against other children, because they think it is normal, some of which were carried out on school premises, indicates not only are children becoming more readily exposed to pornography but they are receiving confusing information about sex from schools who promote lifestyle choices without consequences regardless of their age. The word 'porn' is also becoming fashionably used by adults as a term to describe desires for such things as food and items of clothing. Shoe porn is not an uncommon term for women to use who have a fetish for shoes. The difference however is that porn is violent and an insult to sex, men and women, and should never be normalized in this way.

Fight the new Drug, is a website which explains the addictiveness of porn illustrating how it affects the brain, affects relationships, and affects society. Shockingly, it also states that Porn hub received 33.5 billion site visits last year, surely indicating that adults have very little willpower over their choices once they are hooked upon watching such disturbing images. Last Sunday, I distinctly heard the church bells ringing in the distance. They seemed much louder than usual, and appeared to possess an almost eerie request to their appeal. Maybe, it was the silence in my own home that was emphasizing their tone; they certainly evoked a remembrance of a past life of my time working in the Anglican Church, yet they also definitely had an air of present day danger and warning in their message.

But as I wondered how many people were listening to the sounds of the environment we lived in, I also thought of those who were sleeping through a familiar message which was continually being relayed.

From the office where I once worked I also had views of what is called Beacons which stretch across the country and were once used to emit light or smoke to ships and planes, or else to warn citizens of impending danger. Whilst people were sleeping there would possibly be watchmen looking out for such signals.

We also have a very famous wall called Hadrian's Wall built by Emperor Hadrian in 122 AD who built the wall to protect Roman Britain from Scotland.

It seems strange that the English Heritage website for Hadrian's Wall states as one of its key facts on its home page:

- *Many soldiers and civilians travelled great distances to reach the Wall, including people from modern-day Syria, Romania and North Africa [[Link](#)]*

It is also interesting that Hadrian's Wall known as a UNESCO site (United Nations, Educational, Scientific and Cultural Organization) from its website is celebrating LGBTQ in history along with the National Trust who are an environmental and heritage conservation charity in England. The website states:

- *The Emperor Hadrian was gay. He was married to the Empress Vibia Sabina, but also famously had a male lover Antinoos. Antinoos drowned in the Nile. There are several theories as to exactly how and why he died, but*

These days, and 294 years later, not only the stock market, but the madness of men is still pretty much subject to the ups and downs of fashionable trends, even though there may be a certain trusted psychology to being a wise investor of money. Earlier this year it is alleged that children as young as five were forced to take part in a gay pride event and that no opt-out would be allowed. It is reported some concerned parents labelled 'Christian', as though it were an illness, who confronted the head teacher were reportedly met by a staff member with a tee-shirt which read: Why be Racist, Sexist, Homophobic or Transphobic, when you could just be quiet! The statement shows a complete lack of consideration and respect to any parent who is concerned about their children but is the arrogant response that people who are conveying common-sense are often met with, regardless of the words being displayed on a tee-shirt. It is now reported that it is the parents at this particular school who are feeling victimized in relation to the incident.

For interested parties, the freedom of religion as set out in Articles 9 and 10 of the European Convention on Human Rights

are protected in the Human Rights Act 1998. Under English Law you have a protected right that your beliefs are respected. Under protocol 1, Art 2 of the European Convention, parents have the right their child is educated in line with their religious beliefs, so you are therefore entitled to object to the promotion of promiscuity or indoctrination on the grounds that it conflicts with your faith.

The Tavistock and Portman NHS Foundation Trust in London, is one of many hospitals promoting the Mental Health First Aid course. It is reported that criticisms of their practises



saw divided families who did not fully support their recommendations labelled as 'Negative'.

In many cases they are made to feel guilty for not encouraging or supporting their child down the route of transitioning to another sex.

# 100 Years of Conflict 1918 – 2018

*[These are my views as a woman living in England, on how the culture and spirit of my country has changed over 50 years. Why the country does not feel protected or strong any more, how it has lost, and is losing its values and decency, and how we are daily losing our free speech.]*

Memorial sites, like graveyards, can sometimes be extremely cold places. A small stone plaque with an etched name and a date of birth and death can hardly seem to do justice at times to a life which has touched this earth, and then swiftly left. And then, there are those places where the reality of death as a result of war hits home, and other people's lives can become real and very relevant in your life today.

Such was my revisit last month to Alrewas, in Lichfield, and the National Memorial Arboretum which houses one of the largest memorial sites in the UK dedicated to all branches of the armed forces, and those organizations who are connected to

them.

This time around there was also an exhibition which thoughtfully and audibly recounted the life stories of some of the lives of those who had died or been injured in serving their country. Images of transparent falling autumn leaves continually transposed themselves over the walls and floors of the museum. As you walked around and looked into the eyes of those living and departed, and listened to the accounts of what life was really like and how it is presently experienced in various war zones across the world today, you received a much better understanding. It was however a mixture of emotion and reality, and was something to be cautious of.

There was a large mural which covered one wall and which, from a distance, looked like a forest of tall straight trees; but when you looked closely it was made up of thousands of faces of people who had died, together with the faces of their friends and families. They are the faces of people from all walks of life and religion. It was also like looking through a matrix, a magic eye, with the truth disguised behind an image.

The staff and the volunteers make sure that every guest is welcomed with care and sensitivity and directed to the appropriate location they wish to visit. Some visitors are parents or relatives of young men and women who have recently died fighting in conflict. They come bringing wreathes of red poppies.

The arboretum is an ongoing work in progress as it continually records and etches the names of young men and women who have passed on.

One new memorial that I noticed was one commemorating the destruction of the Twin Towers and was dedicated to those who have died through acts of terrorism. The memorial looked very

small in relation to the other memorials and I remembered how the towers had once stood so tall against the skyline in New York City.

Another new memorial is called 'Still Water' and is dedicated to British victims of overseas terrorism. I thought about the 30 British holidaymakers in Tunisia who were gunned down in 2015 by Islamist gunman Seifeddine Rezgui. Three of the dead were personally known by a work colleague of mine. Yes, the reality of terrorism had certainly come close to home. There are a growing number of people in the UK who now know someone who has been attacked through an act of terrorism.

On leaving the arboretum I also passed through the book shop and noticed one solitary book on the top shelf all alone in the corner. On the cover of the book was the face of Fusilier Lee Rigby who was murdered in 2013 whilst off duty. In a London street he had been intentionally run over and then butchered to death. His murder was reported as being carried out by Islamic extremists, Michael Adebolajo and his accomplice Michael Adebowale.

In 2015, [Adebolajo, sentenced to 45 years](#), attempted to claim compensation of £20,000 after he lost two teeth in a scuffle at the prison.

I wondered if the solitary book was there because people had continually been purchasing it, or if the book was there all alone because people were avoiding it.

The more popular books being purchased were about life during the two World Wars. My own thoughts are that there is a certain comfort in remembering the togetherness and the unity that people experienced during World War I and II. Despite its obvious horrors, people were also more sure they knew who the enemy was and what they were fighting for.

Later that evening, as I happened to listen upon a speech being made by Prime Minister, Theresa May at the UN General

Assembly in New York, I watched her stand in front of a stone cold marble wall so similar to the ones I had seen that day, and I listened with a strange irony to how she stated in one sentence how we should support freedom of expression and a free and open media, and then on the other hand how we should call out those who have hate speech, most especially in relation to all forms of anti-Semitism and Islamophobia.

A small dagger pierced my heart. There was some hatred in her words that ignored the truly noble and the most vulnerable of people.

The dedication that was so solemnly being made, offered truth, but with certain clauses. It appeared to be a weak attempt at appearing strong, and by holding up Islamophobia alongside anti-Semitism it conveyed that together these were the most two persecuted groups in the United Kingdom. It also offered some advantage because of recent allegations made against her own party and the opposing Labour party in the UK who have been accused of anti-Semitism. It was using political correctness to your own advantage.

## Phobia

According to Meriam Webster Dictionary the word phobia first came into print in 1786, along with such words as disorderly conduct, idealize, imposing, Masonic, uncaring and self-respecting. Phobia is understood to be a logical or illogical strong dislike or fear of someone or something. Many of us have a dislike of something, like spiders or heights. When is a dislike deemed logical or illogical and subsequently a phobia? Does over-exposure to the dislike cure a person of their fear?

Islamophobia, a word which first came into print in 1923, is listed thousands of times on the internet and hatred towards Muslims is considered to be a very real and threatening problem. Could it ever be sensibly suggested that based on the

facts of attacks being made on the streets of Europe against innocent civilians that people have a dislike, and also a logical fear towards Islam because it is linked to terrorism and brutality without it being labelled a phobia? What is the motive behind people using this term, and why does the Prime Minister now continually favor its use in her speeches?

This year The Muslim Council of Britain wrote to Theresa May urging her to launch an enquiry into Conservative Party Islamophobia. This was due to former London mayor and foreign secretary Boris Johnson publicly making derogatory remarks about the Burka which were subsequently considered as dehumanizing Muslim women. One could say 'never mind' that the current [London mayor, Sadiq Khan](#), saw no problem in allowing some very dehumanizing images of President Donald Trump to be flown during his recent visit to the UK. However, in fairness he did condemn recent anti-Semitic posters which appeared across London, labeling them offensive.

What is happening in the United Kingdom is people are becoming exposed to a religion, which regardless of its link to terrorism is not prepared to accept any type of humor or criticism that can be happily directed towards other groups in the country. There is indeed a fear of reprisals. In this respect it is at odds against our true values of free speech and openness. A certain respect is being demanded, and a certain secret impatience is admittedly growing.

The prime minister was fueling the flames of this particular division.

Who is truly, noble, pure and righteous?

For the believer, the answer is no-one other than Jesus Christ, who is also the defender of the most weak and vulnerable in society, including unborn children. I have always loved that he is the defender of the widow and the

orphan. War leaves lots of widows and orphans. Yet believers themselves are these days compromising with lots of immoral laws which are being implemented within society. Being labelled conservative or liberal does not necessarily let you know who is right or wrong either and it does not put you on the right hand side of God. These days politics appears to be, as some say, two wings of the same bird.

My trip to Alrewas, was however revealing. Somewhere in that mural, in that matrix which was made up of thousands of faces from various cultures and religions lay some true heroism. As in life, the truth is chiselled in some people's hearts and knowing who is who is not always an easy matter.

With Remembrance Day this year commemorating 100 years since the First World War, we will indeed remember them, how can we forget? Yet, since time has begun, there has been conflict. There is an enmity between those who love the truth and those who don't. There has always been a spiritual battle, and for some reason it seems to be coming to an ultimate conclusion.

Yearning for the truth, has become a matter of life and death. Where will you stand, and how will you be remembered?

# United Kingdom And The Bright Lights Of Malvern

*(These are my views as a woman living in England, on how the culture and spirit of my country has changed over 50 years. Why the country does not feel protected or strong any more, how it has lost, and is losing its values and decency, and how we are daily losing our free speech.)*

Every now and then I take to escaping my urban environment to try and search for pastures new, and the other week I happened to drop in and visit Malvern Priory.

Set in the Malvern Hills it sits high above the surrounding landscape bordering the counties of Worcestershire, Herefordshire and Gloucestershire.

Fortunately for me, when I entered the priory there were very few people inside. No men in frocks, no rituals taking place; just a few people casually walking round and looking at the memorials and the stained glass windows.

After a while I sat quietly away from everyone. Outside of the obvious show of religion I did sense some stability and comfort in the place. There was a certain peace from being set apart from the outside world of chaos. Here, people had come for many years to try and make a connection with something, someone, a deity, outside of themselves. Did they find their heaven?

Some say that the Christian author, C.S. Lewis based his book *The Lion, the Witch and the Wardrobe*, from experiences he had in Malvern.

There is a small plaque indicating that suggestion next to a door at the back of the priory which resembles the wardrobe door from his book. From where I sat, if left ajar, you would

certainly be able to view one of the many lamps which line the streets, which also featured in his writing.

However, it is also reported that one night after leaving the local pub in Malvern he caught sight of a lamp shining in the newly fallen snow which caught his attention and it was this sight that took him to that other place; a land called Narnia – A world within a world where spiritual battles between good and evil existed. Was C S Lewis drunk on drowning his sorrows, or was he really gaining some insight and a glimpse into what happens when you truly search for meaning.

The door reminded me of one of my own experiences that took me away from organized religion, and why I have found my search for a world inside a world a very narrow path.

One day in a crowded church I noticed that the room got very dark but no-one else seemed to notice. As I turned to look at the back of the church I realized that the door was slightly open. There was a bright light in the door which conveyed to me without words to get out of there, otherwise the door would be shut forever. The experience was so powerful that I have always remembered it. What did it mean? There was an obvious message that existed in the light against the darkness which moved me.

The author J. R. R. Tolkien, a friend of C S Lewis and author of the Lord of the Rings, had also walked the hills of Malvern. In conjunction with his catholic faith he too, somehow conveyed the battle for Middle Earth, which could possibly represent England, as a fight between good and evil, light and dark, in his writings. Although both authors are considered fantasy writers, who focus on mythical creatures which include wizards, hobbits, and dragon slayers, their stories resonate quite strongly for many believers and also non believers who realize they are in a battle for their land and a spiritual battle for their sanity and their souls. There is an enemy which is ruthless.

Why isn't the present day church as a whole in the United Kingdom preaching about the spiritual battles in our land? In general, so few will speak about Islam, (not Aslan) which may displace Christianity in the future, they do not talk about politics and laws being passed which affect culture, and they also do not talk about the consequences of sin or forgiveness.

It appears that some preachers believe our battle against principalities, against powers, against the rulers of the darkness of this world and against the spiritual wickedness in high places (authorities) are indeed either myths or parables from the past or best left to a few activists on the street who are much more able to take the strikes of saying it how it is.

Recently, former Archbishop of Canterbury Lord George Carey was accused of failing to act on sexual abuse claims against another bishop, Peter Ball, who was jailed for abusing 18 young men over a period of 30 years.

It is alleged he said *"the church is sometimes "behind the curve" when it comes to addressing allegations of abuse, and that nobody had access to child protection training during a "pre-Savile era"* [[Link](#)]

Historical sex abuse that exists within religion is unfortunately widespread, and has been for many years, but why would an Archbishop who should realize the reality of the battle between good and evil ever be surprised or rely on child protection training when faced with allegations from parents and victims of their abuse?

It seems conditional that there is a certain loyalty to protect each other amongst the priesthood. However, some clergy will often resign or retire early through indiscretions. In recent years though there have been many public exits from staff who cannot and will not compromise upon their beliefs within the changing face of the Anglican

Church.

Lorna Ashworth resigned from the Archbishops Council and General Synod in 2017. In her resignation letter according to Church Times she stated that she refused to be mistaken as one participating in the fanciful notion of “good disagreement”.

Evangelist Rico Tice resigned from the Archbishops Taskforce on Evangelism over the compromises being made under the leadership of Bishop Paul Bayes of Liverpool on same sex marriage. He stated:

*‘I think it is a great wickedness to tell people who are on the road to destruction that they are not. To tell them that they are safe when it comes to God’s wrath when they are not.’*

### **Between Lambs and Lions**

UK film producer, Mark Sutherland who was recently interviewed by Coach Dave Daubenmire of Pass the Salt Ministries was also asked what the church is like in the UK today. He was very aware of the obvious lack of strength and spiritual battles we face.

It was a revelation and a relief to hear him clearly echo the observations made by other people in the UK who have also lost faith in the Anglican Church and see it as a very weak establishment today which is not standing up for the truth.

During the interview, a 10 minute film entitled Between Lambs and Lions, which Mark produced is also shown, it is prophetic to America, although relevant to what we see happening in the world today and is described as being a vision of the future where leaders pay lip service to the democratic process. There are some excellent lines in this short film:

*"Truth is treason in the empire of lies"*

*"If Liberty means anything it means the right to tell people what they don't want to hear"*

*"Vultures don't circle around anything unless it is dead"*

From the viewpoint of standing in a country where the truth is no longer respected, yet amidst a growing crowd of followers in the Evangelical and Pentecostal movements, many people have stated that really it is only a remnant of people across this country who are now still standing firm. I would hasten to add many of these are not outwardly religious people but they are standing in the gap and exposing some of the great injustices taking place within society.

Indeed a lady who wrote to me from Yorkshire in England told me that she had also left the church; and had once saw the whole of the UK as being covered by a large dark cloud. However, now she can see pinpoints of light emerging out of that darkness exposing the truth. Many of them are the most unlikely of people. I see it too. This is encouraging. The vultures are circling, but there is still some truth emerging in this empire of lies.

### **The Ring of Power**

On a final note, the late author, Stratford Caldecott, was also someone who wrote about darkness and light and interpreted The Lord of the Ring in theological terms. He wrote:

*"The Ring of Power exemplifies the dark magic of the corrupted will, the assertion of self in disobedience to God. It appears to give freedom, but its true function is to enslave the*

*wearer to the Fallen Angel. It corrodes the human will of the wearer, rendering him increasingly 'thin' and unreal; indeed, its gift of invisibility symbolizes this ability to destroy all natural human relationships and identity. You could say the Ring is sin itself: tempting and seemingly harmless to begin with, increasingly hard to give up and corrupting in the long run.*

That is a sad but realistic account of how a whole country can become enslaved and corroded whilst thinking it is free. Human relationships and identity are certainly under attack.

The light is still shining, it is but a flicker in the UK, but will we step out into the battle and confront evil, even though it sometimes feels like you are standing alone, whilst not losing faith?

# Dare Speak The Truth And Arrogant UK Authorities Want Your Flesh

The release on bail of Tommy Robinson, the man who was swiftly arrested, sentenced and jailed for 13 months, for reporting on rape gangs which had been freely operating for many years across the UK, [see my article from June](#), bought a very welcome sigh of relief for the many people who had been supporting his cause against an unfair trial and imprisonment.

However, the exposure of the totalitarian manner in which he was treated, whilst reporting on a case which had already been reported in the public domain, and now the apparent consequences of him being locked in solitary confinement in the second prison to where he was moved, HMP Onley Prison, Rugby, appears to reveal a cruelty which seems to outweigh the consequences of his misdemeanour and his conviction. What exactly is going on?

In the following days of his arrest; after the deed had been done, and the reporting restrictions lifted; not only the mainstream media, but legal professionals from every corner of the globe appeared to come out of the woodwork and take great pleasure and a deep sense of superiority in pointing out and justifying the 'real' reasons why Robinson had been locked up.

Justice, they believed, was rightly being served up upon a man who they considered a 'trouble maker' a 'bigot', a 'thug' a 'nazi' and a whole list of abbreviated adjectives which you

would normally attach to a crook who had possibly raped and passed around your daughter. There was indignation towards a man, who albeit slightly irresponsible at times that displayed a hatred which surpassed normal rationality. Why was that? [[Tommy Robinson bailed after Court of Appeal win](#)]

If you have been watching the shift from mutually trusting and respecting another's views to the outright violence and intolerance now being displayed by mainly liberal minded people towards those who see things differently, you will notice that there is very little tolerance being shown towards their fellow human beings, even if that person is presenting some very obvious facts.



Now they live under the premise that if they are offended by your difference of opinion, you are often sued, arrested and made to suffer unmercifully.

Gary McFarlane, a relationship counselor from Bristol, was dismissed for gross misconduct by Relate after he refused to confirm that he would provide directive sex therapy to homosexual couples due to his religious beliefs. **(the offence – conviction of his own beliefs)**

Shirley Chaplin, an NHS nurse, was faced with disciplinary action after being told that she was no longer permitted to wear her cross while at work on health and safety grounds. **(the offence – wearing a piece of jewellery – the cross being offensive)**

A Christian couple were told they could not adopt their two foster children, because of their "concerning" views that the children needed a mother and father. **(the offence – having traditional values)**

Vicky Allen is a teaching assistant who was disciplined for answering a student's question on same-sex relationships. **(the offence – honestly answering a question)** [[Link](#)]

If anyone wants to criticize their religious convictions then they are free to do so; but no one above was inciting violence or causing physical harm. Imprisoning them and punishing someone based on someone else being 'offended' comes from an arrogant spirit which has no tolerance.

As the world slips further into extreme decadence and poverty, both financially and morally, wrong minded people will still

demand they are creating some sort of utopia in this world whilst right minded people are thwarting their plans, and must be silenced and stopped at any cost.

The evidence of an out of control section of society which pouts, uses emotion/tears or out-screams another when another's views are unfashionable or unfavourable to their own is becoming more and more prevalent. Unfortunately, we are witnessing more and more people in positions of authority who are stepping outside a legal framework and punishing others with their own biased views as well. # Tommy Robinson: British Government Threatening To Arrest Journalists For Reporting The Truth

They say that pride always comes before a fall, and if the last few weeks are anything to go by, the United Kingdom has well and truly fallen. How can this be?

One minute the British were waving their flags, bending their knee and tipping their hats at the marriage of the year, and



the next minute we were facing some disgrace over the seizure of an independent reporter Tommy Robinson, who was swept up, arrested, sentenced and imprisoned within

hours on May 25<sup>th</sup>, 2018.

It certainly messes with your emotions.

His crime; reporting outside Leeds Crown Court where 29

defendants were facing charges of alleged sex abuse and grooming of children and young women. He was accused of Breach of the Peace

He was later arrested under the Contempt of Court Act 1981, meaning that because he was live streaming his report outside the court, he could possibly influence proceedings. He had also already been warned previously and was on a suspended sentence. The Contempt of Court Act ensures defendants receive a fair trial.

His arrest sent shock waves around the world, whilst many people in the United Kingdom were still totally unaware, because of a complete ban on the reporting of the events. We were still feeding on the remnants of a royal wedding.

The love affair was fun whilst it lasted, but sadly the reality has now set in and there is a strange and almost threatening atmosphere amongst a certain number of the population as the realization as to exactly what has been physically witnessed in this arrest hits home. Some people are outraged, some are frightened, and many people are just in a state of disbelief because they cannot believe you can be treated in such a way over freedom of speech, most especially when you are reporting on such a hideous crime. They are also 'tired'.

Not far from where thousands of tourists and well-wishers lined the streets to celebrate a wedding, and where the homeless were also swept up and hid away, we now see demonstrators, who some like to call thugs or far-right activists expressing their frustration and their disbelief, shouting shame on the establishment. ## A Right British Geezer

Love him or hate him, Tommy Robinson, whose real name is Stephen Yaxley-Lennon is of course a pretty fearless man, although he does often say he is very fearful for the future of his children. He is down to earth, rough around the edges, street-wise, and has a very chequered past. He has been arrested and cautioned many times, and has also served a jail sentence. He also knew he was breaking the conditions of his suspended sentence. He primarily reports on the dangers of radical Islam and mass immigration in the UK, and for this reason there is often great offence taken against him for his criticisms. ## **Part 2, Of Royal Birth Descended**

It has always been fairly easy in some sense to view the laws of 'cause and effect' in action. In relation to the human body, if it is subjected to a toxic substance, either physically or spiritually, it is more than evident that it will also result in disease, unrest, and eventually death.

Born with no arms and no legs, he was once tempted to take his own life when he was a child. He now travels the world



encouraging and inspiring others to overcome their own personal disabilities; in every way. He gives a message of hope. After the initial shock of witnessing this man, in his very vulnerable state, you realize his spirit has become much more the person he is, than the obvious fact of his disabilities. He is an over-comer and an encourager. He is free.

It is my opinion that if there is a passage from the bible which sums him up, and epitomises who he is, it could possibly be from John 9:2, which surmises that some defects are for the purpose of Gods glory being revealed through them. Who are we to judge?

However, not all people see the potential that our very defected lives can offer. Could it be that there are some people who view others as an undesirable, a mere resource or a burden in society? Is there a race of people who see themselves as superior?

Eugenics, 'the selection of desired human characteristics in order to improve future generations' has both positive and negative reviews, and whilst we mainly attribute negative eugenics to the atrocities/experiments carried out in Nazi Germany, there is a history before the holocaust, which stems from England and also the United States, from which, it is reported, Hitler, and Mengele also drew their inspiration from.

Briefly, British born, Francis Galton, related to Charles Darwin, and inspired by Darwin's book, 'Origin of Species' believed breeding humans with superior mental traits was essential to society. He coined the phrase 'eugenics' and became knighted in 1909 to become 'Sir' Francis Galton for his research and scientific contributions, and it is believed he is responsible for launching the eugenics movement in the UK and also the USA. British Labour MP Archibald Church, possibly inspired by selective breeding, had proposed the compulsory sterilisation, like Germany, of certain 'mental patients' in Parliament in 1931, and although not passed, many sterilisations were forcibly carried out in England.

However, previously in 1907, men, women and children in America thought to be insane, or idiotic, epileptic or even promiscuous were forcibly sterilised by authorities who saw them as unfit to reproduce.

Other countries in the 20's and 30's had also passed similar laws, including the Scandinavian countries of Sweden, Denmark, Norway and Finland. Such was the trend in eugenics.

In researching the history of eugenics you will find a history of sterilisation of undesirable people that our countries would rather forget or overlook.

In Britain, there have been recent cases of forced sterilisation which has brought up the debate on whether it is impinging on a woman's human rights to be [forcibly sterilized](#) whether she has the mental capacity to understand the consequences of her actions or not? [[Link](#)]

It also seems somehow ironic that Francis Galton, who was born in Birmingham, England and studied for two years at Birmingham General Hospital, is connected to Birmingham Children's Hospital, who were accused of removing 1500 hearts from patients without permission from relatives just twenty years ago.

### **Tomorrow's Children**

It appears that whilst we are being encouraged to believe that only positive eugenics are taking place today, by way of research to improve genetic conditions or illnesses, that there is a spirit of superiority which still exists which believes that some human beings are there to be tested upon, saved or discarded in an experimental fashion for another more underlying motive.

Further, is euthanasia, disguised as a type of dignity in

dying, abortion, promiscuity, now being promoted in order to depopulate society in order for those who consider themselves the fitter more elite person to survive? No longer are people forcibly euthanized or sterilised, mankind does this to itself under the guise of 'freedom to choose' whilst it is really under the spirit of what we call negative eugenics, a culture of death and under the same spirit which we attribute to the evil of Hitler's death camps!

Serious thought should be given to the question "are we now living in one big death camp, giving permission, and thanking our captors for killing and experimenting on us?" or "Are we free, kind and compassionate people?"

Has the positive and sincere quest for improving human life through genuine medical research and enquiry descended?

The outright denial of further medical help and care offered to the family of Alfie Evans, following on from Charlie Gard, and the arrest of Ashya King's parents for removing their child from hospital, sadly gives us this impression. [[Link](#)], [[Link](#)]

Hiding behind a plethora of kind words the world was witnessing some very cruel actions.

Sadly, whilst supporters of Alfie Evans family were demonstrating and voicing their concerns, and were being condemned for bringing his plight to public light, celebrations were taking place for pro-choice advocates in London after the UK's first PSPO order (Public Space Protection Order was passed which effectively bans pro-life advocates from being within 100 metres of a West London abortion clinic. To break that law you can face a fine of up to £1000. One can only imagine how PSPO orders will now be used against future pro-lifers or against any other demonstrations or objections raised on ethical issues.

## Of Royal Birth, Descended, Part 1

*[These are my views as a woman living in England, on how the culture and spirit of my country has changed over 50 years. Why the country does not feel protected or strong any more, how it has lost, and is losing its values and decency, and how we are daily losing our free speech.]*

Prince William and Katherine Middleton announced the name of their third child quite recently. It is Louis Arthur Charles, and he will be known as His Royal Highness, Prince Louis of Cambridge.

I noted that the actual birth of Prince Louis had been somewhat low-key, in comparison to previous royal births.

It was a whole week before I knew he had been born. I believe the reason for this was that public world attention was being given to the plight of two year old Alfie Evans, who died under controversial circumstances in Alder Hey Hospital, Liverpool very recently.

Public celebrations for the royal birth also seemed very minimal, and whilst we have delighted in viewing the beautiful photographs of the royal baby meeting his siblings, you could not help or fail to compare the images of privilege and happiness, against the many images of little Alfie, who at the same time, in his own vulnerability, appeared to many people to be in the hands of another authority who did not have his, or his parents, best interests at heart.

The controversy around a court decision to switch of vital life support and refuse his parents permission to seek further alternative help which was being offered to them raised a great amount of frustration for many British citizens who questioned the reason for this. What impact would that decision have on all vulnerable patients, who could possibly have a chance of life?

Some people were very vocal about the treatment of Alfie Evans and his parents, and also against Alder Hey Hospital. There were accusations directed at the demonstrators being insulting to staff and visitors outside of the hospital. [Staff staff spoke of genuine fear!](#)

But not everyone was critical about the decisions being made about Alder Hey Hospital and Alfie Evans.

The Archbishop of Liverpool, Malcolm McMahon, was very 'supportive' of the decisions made by Alder Hey Hospital, but emphasized they were praying for Alfie's parents. [[Link](#)]

The Prime Minister, Theresa May, showed sympathy towards the case but respected the 'difficult' decisions made by clinicians, and it is reported believes that clinicians should decide on a child's life, and not parents. [[Link](#)]

Unfortunately, it appears The Church of England, which belongs to The State of England, and answers to the government have said very little. [Her Majesty the Queen is the supreme governor of The Church of England](#).

Therefore, some people have stayed silently watching. Sympathetic, but silent.

Merseyside Police, who are the police force for the Liverpool area had also issued a statement in relation to criticism against Alder Hey Hospital.

Chief Inspector Chris Gibson said:

*"Merseyside Police has been made aware of a number of social media posts which have been made with reference to Alder Hey Hospital and the ongoing situation involving Alfie Evans.*

*"I would like to make people aware that these posts are being monitored and remind social media users that any offences including malicious communications and threatening behaviour will be investigated and where necessary will be acted upon."*

Somewhere in that silence, where some people have the authority to speak up and make their voices known, and some people are being silenced; and amidst the celebration of new life and a sentence of death for a baby, hangs the truth, staring back at you.

What exactly is going on when parents and children are held in hospitals against their will, and all offers of alternative medical help are rejected? That is the question?

**What's it All About?**

The divide between people who used the words of compassion and dignity to excuse the decision made upon Alfie's life, against those who saw the spirit of arrogance and dictatorship staring right back at them and laying down its law, was tangible. It could not have been more evident. The aftermath of that decision is still hanging in the air. It has left a stale taste and many un-answered questions for those who rely on a National Health Service, and also for some of those who work in the National Health Service.

An establishment which once preserved and fought for human life at all costs, seems to have become infiltrated with a culture of death and decision making which goes against reason. Whilst the public greatly appreciate our medical services, there are also decisions being made which the public and many members of the medical profession are also at odds against. They support the Hippocratic tradition.

Alder Hay Hospital in particular, has already received many bad reviews and has a very dark history which involved organ retention and organ harvesting from children's bodies without permission from parents. During the period from 1988 – 1995 more than 2,000 pots containing body parts from 850 infants were uncovered.

In 1999, the public had been unaware that Alder Hey and other hospitals were retaining patient's organs without their consent.

The Alder Hey report (known as Redfern Report) was published in 2001.

Dutch pathologist Dick van Velzen had ordered the illegal stripping of every organ during a post mortem from every child during his time at the hospital.

The report also revealed that Birmingham Children's Hospital and Alder Hey Hospital gave thymus glands removed from live children during heart surgery to a pharmaceutical company for



research in return for donations.

When Alfie's life support was removed on the 23<sup>rd</sup> April, at the final instruction of the High Court, and he breathed on his own, showing signs of recognition and normality, not only did a population cheer for this little human life, but thousands of medical staff did too.

Many staff who wanted to sustain Alfie's life and give him every conceivable chance was also being over-ruled by senior medical staff and a court system, who it is reported, had refused to consider any appeal by the parents.

It appears they also refused to listen to citizens who pay for the National Health Service, and they also refused to listen to an appeal from Pope Francis in Rome who had granted the child Italian citizenship to be treated in Italy, with absolutely no cost to Britain. On the 23<sup>rd</sup> April, the day Alder Hay Hospital switched off his life support machine, a military air ambulance fully equipped to take Alfie to Bambino Gesù Hospital was already waiting.

The anguish, knowing about that offer of hope for some chance of life, which must have been experienced by his parents, was felt by thousands.

Alfie died on the 28<sup>th</sup> April.

Today, Monday 14<sup>th</sup> May it is his funeral.

We honor his short life. Thank you Alfie for showing us your trust and your vulnerability in this harsh world and from your

silent and peaceful world at least alerting us once more to our responsibility in protecting and valuing human life.

*“If you want peace, work for justice. If you want justice, defend life. If you want life, embrace the truth the truth revealed by God.”*

# **British Double Standard: One For The Royals Another For The People**

*(These are my views as a woman living in England, on how the culture and spirit of my country has changed over 50 years. Why the country does not feel protected or strong any more, how it has lost, and is losing its values and decency, and how we are daily losing our free speech.)*

When I was a child, I had my very own bodyguard. His name was Robert Barker, and he was the boy next door.

If anyone at school threatened me, then the name of Robert Barker would be sure to send just a few shock-waves through the mind of any kid who thought they could beat me up or threaten me. He was a very useful neighbour to know.

At home, I would secretly design wedding dresses; this was my knight in shining armour. He was tall, dark, and had muscle.



One evening, whilst sitting safely on the garden swing in my own back garden, I noticed Robert was looking out of his bedroom window. He vanished, and then returned with his air rifle and shot a bird that was

innocently sitting on a branch right above me. As it landed at my feet, with its wings splayed, I noticed there was blood leaking from its motionless chest. He had already filled my mother's garden ornaments with lead pellets and destroyed them, now he had taken the life of this innocent little bird. There and then, as I looked up and saw Robert Barker grinning from ear to ear with pride, it was decided; this marriage had ended, and it was the end of my very fine romance.

Boys with air rifles were just a little bit too risqué, I would now rely on my own awareness, a bit of charm, and a small black plastic spud gun, which could possibly look real to the unsuspecting.

But as the years have passed in England, and where our total

dependence on an overworked and depleted police force, and a considerable rise in violent crime now dominates society, personal protection seems to only be afforded to those of a special status. Even in your own back garden, there is an extreme vulnerability in every aspect of life for the ordinary man and woman.

### **Peace at What Price!**

As [London is now considered a city to be more violent than New York](#), with the investigation of 55 murders taking place in this year alone, the recent story of a 78 year old South London homeowner, Richard Osborn-Brooks, who recently defended himself and his wife with a 'screw-driver' in his own home, and was later arrested for murder, has brought to light not only what constitutes 'reasonable defence' for an un-armed individual, but has highlighted our own personal ethos, and what weapon, what action, and what tactic we may be allowed to use if faced with a similar situation to Mr Osborn-Brooks.

Following the Bataclan massacre in Paris, 2015, when Islamic terrorists shot and killed 90 concertgoers, staff at my place of work were seriously planning their escape routes should a similar incident ever occur in the relatively quiet, semi-rural, and un-noticeable building that we work in.

Was this an indication of an overly-reactive knee-jerk mentality to an isolated event, or a realistic view of just some of the dangers we now face in Europe?

Our cities, towns and some of the surrounding suburbs have now become places where your only protection may be to avoid them at all costs. If you have to travel through some area's you lock your doors, and you most certainly do not partake in any type of confrontation with another driver or get out of your car. At a moments notice, the polarization of yourself as an individual and the area that you find yourself in may become painfully clear. The streets now belong to a more aggressive

and streetwise individual, who, in the absence of a police presence, has claimed ownership. Whereas, these areas were once in a minority; like a virus, petty and violent crime is spreading and it is creeping up upon many areas across the country which were once considered relatively safe.

In many instances, the law is also favouring the side of the aggressor and not the victim. This is creating an overall tension, a state of suspicion, and an increased fear across the country. The initial arrest of Mr Osborn-Brooks, although he has now been released, raised an overall national outcry. This is because there is now a very long history of unfavourable outcomes which has seen perpetrators of crime walk free based on their human rights.

As we live in a country where individual protection has been largely handed over to the state, people are now crying out for more law enforcement and a more visible presence of police on our streets. However, will this usher in a police state, where we might see armed servicemen and police patrolling the streets as we once witnessed in Northern Ireland (1969-1998) Is this now our very own era of '*troubles*'? ### **A Return to the Garden**

Today in 2018, because of the increase in crime in the UK, I would once more dearly love to have my very own Robert Barker to keep a watchful eye over me. Despite his child-like enthusiasm to impress the girl next door by shooting a bird, in our school days he still had a heart for protecting the weaker person from the bully.

In the face of the continuous growing evil which we confront today, I have slowly re-kindled my love affair towards those who know how to physically protect themselves. I understand

more clearly the battle we face in an imperfect world.

The reality is that evil holds no fear in killing someone. Your charm or vulnerability, and even an escape plan, cannot deter an assailant who wishes to destroy you. Mr Osborn-Brooks only had a screw-driver to protect himself and his disabled wife. Unfortunately, it fatally wounded his assailant, but what would have happened if he had not attempted to protect his family?

How fortunate are those who are able to be physically protected?

In 2013, whilst walking in his own back garden in the grounds of Buckingham Palace, Prince Andrew was not so grateful. # School Shootings And Cover-Up In Britain

*[These are my views as a woman living in England, on how the culture and spirit of my country has changed over 50 years. Why the country does not feel protected or strong any more, how it has lost, and is losing its values and decency, and how we are daily losing our free speech.]*

*For we wrestle not against flesh and blood, but against principalities, against powers, against the rulers of the darkness of this world, against spiritual wickedness in high places. –Ephesians 6:12*

Considering I live in a country where the majority of people have never owned a gun or even seen a real one; there's an awful lot of talk about gun control going on over here.

Sparked once more by the most recent mass shootings in Las Vegas and Florida, our mainstream news seems to be vehemently attacking the American people, and in particular, its president, Donald Trump, for protecting second amendment rights on a monumental scale.

Leading the way, British journalist Piers Morgan is one of the most formidable and aggressive forces amongst us, in his attack on gun ownership and its laws in America. Highlighting the obvious random murders which are carried out by gunfire upon innocent adults and children, he appears to be championing a cause which many British people support.

Maybe, it is our obvious differences in how we have been exposed to firearms that creates the chasm, and now affords such support; but are countries which now live under very



strict gun ownership controls any safer than in America, and do will live under an illusion of feeling protected based on our past history as being a country with one of the lowest rates of gun homicide based on tight gun control?

I have discovered, one of the most stringent gun control laws enforced in the UK came about in the late 1990's when a ban was made on all handguns (*with the exception of those chambered for .22 rim fire cartridges*) by John Major under the conservative government and later by Tony Blair under the labour government who went on to ban the .22 handguns. This came about after 16 children aged six and under together with a teacher was shot and killed in a primary school in Dunblane, Scotland in 1996. [[Read](#)]

Dunblane, which is a small quiet village, was visited by local resident, Thomas Hamilton, a legal gun owner, early one morning just as school had started. He proceeded to walk through the school, opening fire and randomly shoot children.

Today, the public are unable to read the full investigation into Dunblane, called the Cullen Inquiry, because of a closure order preventing publication for 100 years. However, some of the documents were released in 2005 revealing that Hamilton had previously been under investigation by Child Protection for many charges which included assault and obstructing police. It is reported that no action was taken.

Dunblane seems to hold a 'secret', and an untold story. It is very evident the village is united and not quite at peace about the outcome with the inquiry. I don't blame them. The question on why no action was taken against Hamilton has raised some accusations of there being a cover-up.

In Dunblane Cathedral is a beautiful sculpture to the children who died. On one side of the sculpture it reads

*"But still I dream that somewhere there must be the spirit of*

*a child that waits for me”*

The quotation to me seems to sum up a loss of innocence on our own part, besides being dedicated to the families and children of the Dunblane Massacre. [[Read](#)]

### **Knife Crime in the UK**

The UK is no stranger to random attacks upon children in schools.

In 2001, I happened to work for a short time for an organization called Spurgeon’s Child Care. In a new initiative to recruit volunteers to visit children who were in care, and to launch the project, I was delegated to find a suitable celebrity to speak at the launch. It was a difficult task. Eventually, I wrote to a young lady by the name of Lisa Potts, who had been awarded the George Medal for her bravery. In 1996, she had been working at an infant school as a nursery nurse and a man entered the playground and proceeded to attack them with a machete. In attempting to protect the children, one of Lisa’s arms was almost completely severed, and she suffered severe cuts to her head, back and other arm. Several children were also very badly injured.

The assailant, Horrett Campbell, who was arrested the day after the attack claimed that he heard voices, and that he was told the children ‘represented the devil’. It is also reported that he idolized the killer Thomas Hamilton, the murderer of the Dunblane incident.

It is reported he showed no remorse and saw what he had done as a good thing. [[Read](#)]

Currently the number of people owning licensed firearms in the UK is 2 million together with 1.3 million legal shotguns in England and Wales. This does not account for the number of illegal owners. Every household most certainly possess knives, although a machete cannot be accounted for. There is

a significant rise in both gun and knife crime in the UK, and whilst some British citizens live under a false sense of feeling protected, some are very aware of our vulnerability in a world of increased violence which now incorporates terrorism. We are also aware of no-go areas, honour killings, child abuse on a grand scale, an increase in rape, human trafficking and increased drug and alcohol addiction within the population. In respect of mental health problems, health agencies report that patients with mental health problems are more of a danger to themselves than other people. [[Read](#)]

Time to Change, an organization which aims to change attitudes towards mental health states:

“The majority of violent crimes and homicides are committed by people who do not have mental health problems” [[Read](#)]

My own thoughts are that violent crimes and homicides are not committed by anyone who is in a ‘balanced’ state of mind.

We should all strive for a balanced mind. This is under threat.

On a daily basis our exposure to crime and fear, with fear being the operative word is growing; and yet to speak out about fear of terrorism, or our caution around some people who appear to be very unbalanced, is becoming the worst crime of all.

## **Hate Speech**

Hate speech seems to account for anything which might offend or hurt someone else’s feelings or views. It can lose you your job, imprison you, and isolate you. It is extremely one-sided.

Those who feel you are being hateful by pointing out obvious facts can be very aggressive.

Many tactics used by hardened news reporters, politicians, some activists (and journalist’s) can bully you down into

submission by over-talking you, accusing you, contradicting you and confusing you.

We live in a Dunblane scenario of hidden truth and suppressed facts. Innocence becomes lost. We die internally, our voices not heard; resentment and injustice grows, our thoughts torment us.

Thoughts can become audible; good becomes bad, and bad becomes good. Confusion is life threatening because it can change your identity.

In a recent interview with British journalist Cathy Newman and her guest, Canadian professor Jordon Peterson on the gender pay gap, the questioning became an interrogation using all of the above tactics. When Peterson was accused of offending other people he admitted that this is what we must risk and accept from each other in order for healthy conversation and he had sat for a long time being offended and made very uncomfortable by Newman's questioning. He displayed a vast amount of grace and wisdom during the interview. He did however know his enemy. He knew that which was outside him and he knew that which was inside himself.

# Will The British Government Control Sexual Values Of Its Citizens?

## Pompeii Meets Piccadilly?

Apparently, over 100 million people pass through Piccadilly Circus, in London's west end each year. Known for its large illuminated advertising space called 'Piccadilly Lights', which has recently been refurbished, and for its many theatre's, shops and restaurants; it is one of those iconic landmarks, a tourist attraction and meeting place.

British people will often refer to any crowded place as being 'just like Piccadilly Circus'. It is one of those colloquial sayings we have, which even if you haven't been there, will often be recognised for the state you are referring to. It is loud, busy and chaotic. When you visit Piccadilly Circus you can keep going round in circles. It is where many roads meet.

It has featured in such films as *Whatsoever a Man Soweth* (1917) *The 39 Steps*, (1935) *Don't Look Now* (1973) and *V for Vendetta* (2005)

In 2002, it is reported that Yoko Ono, widow of the late John Lennon, paid for a banner to be displayed for 3 months in Piccadilly Circus to display the words from his song *Imagine*; "Imagine all the people living life in peace" to promote world peace in the wake of September 11<sup>th</sup>.

In theory, it is one of those places which will demand your attention with its messages. You can't get advertising much bigger or bolder in the UK than in Piccadilly Circus. You just need the right amount of money.

However, this week a much quieter event should have been taking place there. Passers by and tourists may have been totally unaware of its presence as their attention would be averted by the bright lights of advertising. The premier showing of a documentary called 'Voices of the Silenced' was scheduled to be taking place to a private audience at the Vue Cinema.

The film had advertised on its website that it would be highlighting the goals of sexual politics and the silencing of views which are in opposition to the pansexual cultures of the pre-Christian Graeco-Roman world.

It also asked an important question:

Will the church recognize the dangers of capitulation to state control of sexual values and a return to the ancient cultures that its Jewish roots taught it to reject?

The organization, Core Issues Trust who support people who wish to move away from same-sex attraction, had filmed their documentary across seven countries, speaking with various professionals on the subject, and it contained interviews with people who had voluntarily sought counseling.

However, it is reported that after details were obtained by Pink News, [an LGBT news publisher, 600 people petitioned for the screening to be cancelled](#); which indeed, at the last minute, it was.

In the many interviews which I have listened to which feature Mike Davidson, who is the director of Core Issues he continually re-iterates that they never promote 'gay-cure' or 'conversion'. They are terms which are continually used by

opponents who wish to discredit the help that they offer.

Baroness Barker from the House of Lords made the following statement for Pink News:

*"People who preach gay conversion therapy are zealots who are prepared to cause great harm to LGBT people in order to perpetuate their warped view of the world. Happy, healthy societies should send them packing."*

If we are in any doubt that we are living in a society that is being dictated to on its sexual values, showing no consideration to another point of view, then the boycotting of a film called The Voices of the Silenced has pretty much summed up the frustration and the hypocrisy that many people are witnessing and feel unable to express.

Apparently, over 3 million people also visit the ancient ruins of Pompeii in Southern Italy each year. Eager to view the city which was first discovered in the 16<sup>th</sup> century, ongoing excavations have revealed a preserved city that sheds light on how people lived in the ancient world.

When I visited it was a quiet, peaceful and sunny day with very few tourists.

When you are there you are always aware of the presence of the volcano, Mt Vesuvius which dominates the skyline and which buried Pompeii under volcanic ash when it erupted in A.D 79, on an equally sunny morning.

An eyewitness during the time of the eruption who lived across the Bay of Naples recorded "Darkness fell, not the darkness of a moonless or cloudy night, but as if the lamp had been put out in a dark room". (Pliny)

The excavated city reveals a well designed and affluent city where wealthy Romans would have resided or visited. There are many temples all dedicated to different gods, Apollo, Jupiter, Isis, Fortuna Augusta, Vespasian. There are political messages etched on the walls of the houses, together with rude critical messages aimed at specific citizens (a bit like face book or twitter)!

The many fresco's and artwork discovered depict a lifestyle that was indeed pansexual. The images can be quite shocking. Some are pornographic. Eroticism was valued and magic was routinely practised. It is very clear without a doubt that it was a life that was not hidden. Prostitution was legal. Slavery was rife. In fact, Pompeii seems to be known for its unlimited sexual licence. Anything goes.

Contrary to [people thinking that Pompeii is the revelation of a bygone culture](#) that has died it is evident that all of those practices are being dictated and resurrected into this present age.

## The War Of Attrition

Attrition warfare, a process of wearing down an opponent has been taking place, 'spiritually'. Your energy has been stolen, bit by bit, to feed an entity that has no decent life force of its own. It has used the adage of the 'common good' or 'keeping the peace' as a tactic against you in its arsenal.

On a global scale, this invisible entity has also been building up an army of soldiers and snipers to use ammunition to fire against its very own comrades.

Covert agents are everywhere residing in the media, government services, the health service, education, and religion.

Death is the outcome. You are the target, and your co-operation is demanded, and not requested.

### Common Purpose

Cultural Intelligence training, which also works alongside Emotional Intelligence and considered a vital requirement if you wish to get on in leadership positions; may appear to be a very considerate way of respecting the differences in other cultures or lifestyles in order to work more effectively in business.

However, in effect, is it really about learning how to make a multi-cultural society blend into one, and is it side-lining anyone's beliefs that just may not tie up with common purpose ideals?

Cultural Intelligence talks a lot about your core and your flex. The core is who you are and the beliefs that you have and which should not change. The flex is your adaptability, your knowledge and your consideration towards other cultures in order to work together without changing your core.

However, one does not have to assume what cultural intelligence is, when on a daily basis we personally experience the reality of the very biased consideration which is continually being given to others. The foundations of the British way of life have been sacrificed and it has lost its own identity.

Consider just a few examples of what is really taking place.

*The case of Joshua Sutcliffe, a Christian maths teacher at a school in Oxfordshire facing discipline for calling a female student a 'girl' when they wanted to be called a boy. The school has accused Joshua of 'mis-gendering' the pupil contravening the school's equality policy.*

*Richard Page, a magistrate who has been disciplined by a Cabinet minister and England's highest judge for saying that he thought a child's best interests lie in being raised by a mother and a father.*

*Barry Trayhorn, a Pentecostal minister forced to resign after a complaint was made about a bible verse he quoted at a prison chapel service.*

*(These cases are being defended by Christian Concern lawyers)*

All of these cases have happened within health, education law, and religion, and are not isolated cases. They happen on a daily basis.

The above people are being punished for their 'beliefs' which can be kept private, but never expressed. They now stand outside the new norms of society, as they have not yet conformed or compromised. They unfortunately will never be able to have enough 'flex' to progress in their careers in society, despite being very gifted and experienced people. They must be punished.

With emotional intelligence, cultural intelligence and social intelligence all being used as a superior standard of interacting with people, the genuine is becoming lost and we live in a false world of caring for each other, whilst destroying each other with lies.

People are suffering under attrition warfare, a sustained process of wearing down an opponent until they physically collapse and they lose the will to fight.

As Christ was crucified on the cross, the truth is being crucified in the UK.

Who will win this War of Attrition, and which side will you stand on, the winner or the losers? Who is your leader, and who are you following?

## Bearing Crosses

*(These are my views as a woman living in England, on how the culture and spirit of my country has changed over 50 years. Why the country does not feel protected or strong any more, how it has lost, and is losing its values and decency, and how we are daily losing our free speech.)*

One of my favourite illustrators was Annie Vallotton, who is best known for her stick figure illustrations which feature in the Good News Bible.

Who would have thought that simple black and white pictures could convey powerful messages; but in Annie's illustrations it would be fair to say that the holy-spirit certainly speaks through them.

The most striking illustration which always intrigues me is one of many people all carrying crosses. In the illustration there are young and old people, and some are very small children. The crosses are also of different sizes. The caption reads:

*"he must forget himself, carry his cross, and follow me" Mark (8:34)*

The picture indicates we are all carrying some sort of cross in our lives, and a good friend explained to me once that our crosses are made lighter by Christ inside us who bears the heaviest part of that cross for us. I love that. There are sometimes issues in our lives that could crush us if it were not for a strength that is bigger than our own weak selves.



People are very good at wearing crosses, you see them all around you, but they are not very good at carrying their cross or of knowing how to. We talk the talk, but can't walk the walk.

Crosses can make a statement of faith or also a statement of fashion. You sometimes see large diamond studded crosses hanging round a person's neck, and you sometimes see them being paraded down the aisles of a church. But who it is that wears them is not always a true reflection of truth. You see their hypocrisy. Fashion has infiltrated churches and

watered down the message of the cross. There are many theologians who are now fashion-statement bearers.

Therefore, discovering the truth, or having the truth revealed to you, for many Christians, has become a singular journey now outside the confines of organized religion, church buildings and fellowship.

### **The Conversion of the Church of England**

\_It is very sad to say that if you are looking for answers you will not find them today within the Church of England as a whole. Many Christians have lost all respect for what is known as the General Synod of The Church of England in the UK who can make decisions which, if approved by the Houses of Parliament, can define the law and also influence the spiritual lives of their congregations. Unfortunately, they have failed to convey the message of the gospel and the many people which they should have really helped, stand outside its walls. Weakness is epitomized in many of the clergy who cannot speak the truth in love, or offer hope to people who look for true answers.

It is disappointing that the Archbishop of York, Dr John Sentamu is reported as saying "[The sooner the practice of so-called conversion therapy is banned, I can sleep at night](#)".

One might initially think the conversion he speaks of is the conversion of the church, but his remarks are aimed at the counselling and the help that many people seek for unwanted same-sex attraction.

By calling it 'so called conversion', he suggests that people are being forced or manipulated into seeking help to change their nature, rather than return to their basic nature and to what they feel is right. The church, in this respect, overlooks the thousands of people who have found great help and support in talking to someone who understands; which includes people who were sexually abused as children and feel

their same-sex attraction is somehow connected to that experience! It includes the many people who feel their need for a father's love became sexualized at some point in their lives. It includes the similarities in a person's childhood or a trauma that can be identified in so many stories, which at least offers some basic understanding of the spiritual war they may be experiencing.

Whereas, proponents of banning this help can recount many stories of people who were not helped by therapy, there are also thousands of stories of people who have been greatly helped and supported in overcoming the desires that they experience.

Should the church be trivializing and dismissing the very real changes that many people want and have experienced. Why are their stories being silenced?

Often opponents to [present day therapy will bring up the use of electroconvulsive therapy](#) or castration which was once used against people with homosexual tendencies, but this is not used in modern day counselling. However, ECT, electroconvulsive therapy is still widely used for mental health conditions which can include depression or psychotic episodes. It could be considered to be a violation by any number of people. It may certainly be a cruel answer to a spiritual problem. You can read about how ECT is used today here:

The motion to bring about the banning of therapy was brought to the General Synod by Christian gay rights campaigner Jayne Ozanne stating "the therapy is potentially harmful with no place in the modern world".

But here is the hypocrisy. It is reported the [Church of England overwhelmingly called](#) for a ban on such therapy for gay Christians after overwhelmingly affirming transgender people in the church. What sort of double standard is this

that would remove the choice from one group of people and then affirm the choice of another, and are they aware that organisations, who offer help for unwanted same-sex, also have to offer help to many [trans-gender people](#) who regret the transition that they made?

Children and adults who look for answers as to why they have certain feelings often feel extremely rejected by God. There can be no denying there is a certain amount of suffering and bullying that they may have experienced. Society is cruel on many people for many different reasons. They will however sometimes look to the church or the medical profession for an answer. They should be more consciencous of what they say in the position that they are in. Sadly, they are not.

From strongly criticizing and condoning certain behaviours to affirming or being indifferent to certain behaviours they have failed on both accounts to give the correct understanding, merely because they are fashion statement bearers. There is no real spiritual love in their actions.

Spiritual and physical abuse within religion has destroyed many believers.

## London's Big Ben Is losing It's Gong

Stop all the clocks, cut off the telephone,  
Prevent the dog from barking with a juicy bone.  
Silence the pianos and with muffled drum  
Bring out the coffin, let the mourners come.

Big Ben is the large clock, situated in the Elizabeth Tower at the north end of the Houses of Parliament in the capital of

London. It is one of those iconic buildings by which the United Kingdom is often recognised. No matter where you are in London, Big Ben (which is the nickname for the bell inside the clock) can usually be heard. But on the 21st August, it is about to become silent for 4 years. It has been chiming for almost 160 years, and like the roots of an old oak tree it offers some people a certain sense of comfort and stability. The sound of its gongs as they are sometimes called, are indicative of London and its history.



On British TV a picture of Big Ben and the sound of its gongs have signalled in the evening news on a nightly basis across the nation. It has famously introduced state occasions. It is known for the eleven solemn gongs on Remembrance Day signalling its citizens to remember those who have died in wars; and besides its face on the numerous tourist souvenirs of tea-towels and fridge magnets depicting the London scene, perhaps it is most widely and emotively remembered by the older generation for the famous speech made by Sir Winston

Churchill announcing to the world that the war was over on [V.E Day in 1945](#). The three introductory gongs at the significant time of 3.00 p.m. on the afternoon before his announcement are particularly relevant to the occasion.

Therefore the news that Big Ben will have to go silent for four years, due to Health and Safety issues for the workers who have been set with the task of renovating the clock, have raised immediate objections that London, and indeed the UK, would not be the same without its gongs. Some have called

it 'PC madness', especially when sufficient ear defenders could be supplied to the workers.

There is a slight panic across the nation. For some British people, that sudden loss of all that is familiar may have suddenly hit home.

What will fill their silence?

Homing in on the issue, the Prime Minister, [Theresa May, has also raised her concerns on its silence](#), along with other notable MP's. It sounds like they couldn't have possibly known this was about to happen, and in their very own house as well! A suggestion has been made that a recording of the gongs set some distance away may be the solution for those who will suffer from the silence of Big Ben, and as a bonus, the health and safety of the workmen will also benefit.

There may be nothing like the 'echo' of times past to give people that false sense of security, regardless of whether it is authentic or false, and there is nothing like a false sense of caring for people too.

So why is our famous tower and clock being dismantled and renovated, and what is the cost? In monetary terms it is £29 million.

But Big Ben and the Elizabeth Tower is not the only British institution which is facing some updating.

## **Pride and Prejudice**

The National Trust, an organization which looks after the conservation of stately homes, gardens, historical sites and landscapes, all of which are very popular tourist attractions for many people in the UK, has been embroiled in rows this year, this time, all connected to political correctness.

Supported by over 70,000 volunteers and maintained largely by the 4.24 million people's membership to the The National

Trust, who value their heritage and wish it to be protected; National Trust properties are wonderful places to visit and escape the concrete jungle of urbanism.

However, earlier in the year the organization did not think seriously enough when they decided in their [collaboration with chocolate manufacturer 'Cadbury's' that now was the time to go along with removing the word 'Easter' from their annual Easter egg hunt and how much the public would object](#). Not that the children minded, as they are more interested in the chocolate, but the significance of the subtle advertising and the removal of everything which could possibly refer to Christianity was noticeable even to the most secular. It didn't go un-missed.

Also this year the National Trust who are now marking the 50th anniversary of the partial decriminalisation of homosexuality, and exploring LGBTQ heritage with a programme called Prejudice and Pride at some of its sites, have been accused of forcing their staff to wear gay pride badges, or else be relegated to back room duties.

Now reversing its decision after the news became public, Dame Helen Gosh, the director of the National Trust is reported as still defending the original decision in a letter to the Daily Telegraph which reads:

"Like many heritage organizations, [we have taken the opportunity of the 50th anniversary of the partial decriminalization of homosexuality](#) to tell the story at a dozen or so of our properties of the people who lived there and whose personal lives were outside the social norms of their time,"

Christ's murder had to be the most cruel and undignified way of dying.

The sweetness of just standing there in those beautiful surroundings, in the open air, free from the constraints of brick and mortar, ritual and words, with the realization of what he overcame and what he did, had an instant healing affect. There is a deep and meaningful message in silence which only he can convey to the human heart at times. It stands in deep contrast to what the world's view of love really is, and what it prides itself upon.

## **Visions, Values and Beliefs**



The current global furore surrounding baby Charlie Gard, who is currently in Great Ormond Street Hospital, London, silently waiting to die, after doctors have said there is nothing more they can do for him, has once more raised some serious

questions in our attitudes towards suffering. [It has also raised some questions about our National Health Service for many people.](#)

There is a lot of discussion about compassion and dignity towards others. There is also a lot of frustration being experienced by the public that the parents of Charlie have been denied the opportunity by the legal systems to take their son to America to try a new experimental treatment for him.

There also appears to be a global debate taking place, not least in British newspapers. There is a divide on whether we should trust medical experts at Great Ormond Street Hospital and let Charlie 'die with dignity', or if the parents should have been allowed to take their son to America.

Thumbs up for yes, and thumbs down for no.

It all seems really sick and cynical when you think of his parents, and the anguish they are experiencing. A decision has already been enforced. Did they really have an option?

Surely, under these circumstances, the decision for Charlie's health should have rested with his parents. He is their son. [It has also been reported that they are not allowed to take Charlie home to die.](#)



However, social media and the mainstream media are also playing a pivotal role in alerting us to something else. It is the power and the authority that the government uses in what is called socialized medicine in relation to our children which is coming to the forefront. Whereas, we once believed and trusted in the advice of doctors, a dictatorship appears to have been visibly rising which determines the outcome of health, outside of parental control.

It is not unusual to daily read of people who have been denied treatment because of the expense to the NHS, or to hear of desperate parents raising money to try alternative treatment available in America. When I read about the plight of the parents of Charlie Gard who had been denied the right to do what they could for their son, it also reminded me of the case of [Ashya King who I wrote about some years ago, whose parents were the victims of an international hunt](#) after they removed their son from a hospital in Southampton, without the doctors permission, and took him to Prague for Proton Beam Therapy which had also been denied him in the UK.

Social media had been adept at highlighting the cruel way in which the family had been treated during that time when they had been arrested and locked up in a Spanish prison. It was an

embarrassing unfortunate case for the UK, which was very quickly covered up by the government's intervention to then help them.

Labelled as irresponsible for putting their son's life in danger, there was evidence of a certain 'power' and an 'authority' which had been exercised in over-riding the parent's wishes, and actually arresting them. So what is going on and do we really show compassion and dignity to those who are vulnerable and suffering or do these concepts of dignity and compassion really cover up a cruel system of power over its people?

### **Our Culture Of Death**

As I turned the pages of a well known British Newspaper to read of the plight of baby Charlie, it was sad to see the love and the sorrow in the face of Mr Gard as he cradled his very poorly son.

On the next page of the paper was a picture of tennis player Serena Williams in the famous iconic nude pose now portrayed fashionably by celebrities who publicly wish to show off their baby bump.

And on the next page of the paper was the story and photograph of a transgender couple who have been allowed to not state the gender of their baby on the birth certificate until their baby is old enough to decide what they want to be themselves.

There were some very mixed and confusing messages in those particular images as I travelled along its pages.

And in a country where we are seriously considering and debating the abortion of babies up to full term for whatever reason, are we really a nation of compassionate and thoughtful people towards children.

### **A Matter of Inconvenience**

Attacking human life, rather than preserving and protecting all human life, the term of 'Antiquated' and 'Victorian', was used quite recently in the House of Lords to pass its first reading to completely decriminalize abortion.

The ten minute rule bill led by Labour MP Diana Johnson and backed by the abortion industry BPAS cited section 58 and 59 of the 1861 Offences against the Person Act as being outdated and unfair. It was reported that it was passed when women didn't even have the vote and was not in line with modern day Britain!

- "There are things that I see when I'm driving around Birmingham that shouldn't be happening. I only drive into these areas, never actually walk into these areas, I just wouldn't. Just in case I did do something that...because of their culture or their religion it was a threat or it was an insult or something." – Resident of Birmingham.

Who will fill the Void?

The protestors in the Women's anti-Trump march I fear are being used in varying ways. ## The Midnight Cry

“It was a tremendous rumbling sound and all the school went dead. You could hear a pin drop. Everyone just froze in their seats. I just managed to get up and I reached the end of my desk when the sound got louder and nearer, until I could see the black out of the window. I can’t remember any more but I woke up to find that a horrible nightmare had just begun in front of my eyes” -Gaynor Minett

The Welsh mining town of Aberfan lost their children en-mass on that fateful day in 1966. It has been 50 years ago, but the heartbreaking images of parent and rescuer digging and scrambling through the tons of black slurry that had suffocated teacher and child as an avalanche of waste thundered down the hillside on to Pantglas Junior School, is something that many people can still vividly recall.

For 50 years prior to the incident, the mountain waste made up of millions of tonnes of mining debris had been steadily growing and for almost as long the numerous petitions for its removal had also increased. It appears to have been one of those constant battles that we daily witness between sensibility and indifference, where indifference blindly persists and the common sense approach is dismissed, until it is ground down into submission.

Today, for those living in Aberfan, and for all those who survived, there is a daily reminder apart from the annual

memorials and missed anniversaries that there are 116 children's graves all bearing the same premature date of demise. There is also the constant remembrance of the unexpected, the unbelievable, yet the forewarned tragedy just waiting to happen. Could they have done more?

One parent whose child died in the disaster asked that it be recorded that the cause of death was "Buried Alive by the National Coal Board"

From others, and the memory of what happened at Aberfan, it is sadly reflected by John Adams as he writes:

I was 14 at the time of the Aberfan disaster. My school was very religious, and I had been trying to decide how much I believed in God. When the disaster struck it was the talk of the school, and in many of the classes we found ourselves discussing it with our teachers. We particularly wanted to know why God would allow so many children to die. The teachers had no answer. I turned away from the idea that there is a God. And that's my view, to this day. [Read]

Mr Adams wrote a reflective account of how he now experiences God and it is how many people feel when disaster strikes. Indeed, if people are genuinely honest with themselves there is a rejection and a deep resentment within them for even the smallest of slights against a being that we are told loves us.

Deeper questions on the relevance of an intelligent force of Good which appears to allow disaster, against an intelligent force of Evil creating disaster are rarely discussed.

Yet today more than ever we are witnessing the unleashing of evil in all its forms in a way that is obviously not hiding from us. Like the mountain of black slurry that was piling up on the hillside of Aberfan, it is in full open view. It is slithering its way in to every persons home, school and church at rapid speed. Why can't everyone see it, and why do some people promote and protect it?

We are told evil comes to kill, steal and destroy every man, woman and child who has a destiny. We have an adversary. Realizing there is some type of intelligent force orchestrating our demise is probably one of the most frightening revelations you can experience. Realizing there is an intelligent force which can operate with extreme subtlety and patience, precision and planning, and which can also use you to destroy others is equally disturbing.

Abortion on Demand – Whatever the Reason

In a world where abortion has for the main part been legalized in so many countries, we still live in a world where the ugly reality of gender abortion (mainly the killing of baby girls) still brings up some pretty startling reactions. ## The New Normal

Many people reported on the article that genuine compassion and understanding should be directed towards any child with such issues, but imposing and promoting acceptance on sexuality at such tender ages like it doesn't matter, is creating a distorted and dangerous view which could harm a child in later life. Those petitioning for such acceptance selectively remove or condemn any counter-acting scientific evidence provided against the danger.

Whilst the child's mother believes we should talk about such matters, we live in a world that rarely reports, wants to know, and even vehemently silences the reporting of transgender/transition regret. There is a very high incidence

in people who transition; but still do not find the happiness they think will discover from trying to change their bodies.

In a 1973 – 2003 study in Sweden on 324 sex re-assigned persons the conclusions following the procedures were found to be that there were even higher “risks for mortality and suicidal behavior” You can read the report [here](#).

Author Walt Heyer, from his website ‘Sex Change Regret’ also offers a wealth of information with links to research and factual evidence that people need to know. He writes: “Most will grow out of the dysphoria. Isn’t there some way to work through the distress rather than experimenting on our children”?

Interestingly, you will also find that many people who are considered LGBT have also distanced themselves from identifying with this type of promotion in our schools and society.

## Remembering Kenneth Hayes

The Rev Kenneth Hayes was 36 years old and was the minister of Zion English Baptist Church in Aberfan in 1966. Despite losing his own little boy in the black landslide, he reportedly preached the day after the tragedy and in the years that followed continued to encourage and help all of the grieving families in the village through the example of his own unshakeable faith in a loving God and a life thereafter.

I believe, despite his own grief, he will have undoubtedly brought some light and hope into the darkness which smothered 'Aberfan', a tiny welsh village whose people still bears many mental scars.

He also reportedly never stopped speaking up about the removal of the black tip which killed 144 people and later headed a campaign to remove remaining tips. One of the greatest scandals known about in the UK was the coal board being allowed to take money from the disaster fund set up for the victims to remove the tips. Years of petitioning by Kenneth



Hayes saw the money returned in 1997.

The penalizing of Aisling Hubert for seeking justice; the biased reporting on transgender issues; the unknown numbers of children in sex-selective abortions; rife and ritual child sex abuse. # A picture can paint a thousand words

Last week a friend gave me a copy of an old German painting called *Det Breite und det Schmale Weg*. Translated it means 'The Broad and the Narrow Way'. I had noticed a framed edition on her kitchen wall and my attention had been continually drawn to it. There was a certain pain and a certain hope entwined within it.

Designed by Charlotte Reihlen of Stuttgart in 1862 it was then painted by Herr Schacher also from Stuttgart, and later editions were produced in Holland in 1866.

Aside from the two obvious paths depicted in the picture, and although there are English editions, a German translation book and a magnifying glass revealed minute and interesting details in many of the figures. There were scriptural references under some of the scenes. The images were so comparable in how we personally experience life today.

Of course the broad and narrow way is sometimes discussed within religious parlance; and there is a belief that only a few are seriously on the narrow way to life eternal.

Outside of that discussion, the way to heaven is wide.

Everyone thinks they are going there.

Today, so many people are compromising themselves through their very own interpretation on what constitutes the 'right' way of living by listening to people who they believe to be experts, religious scholars, enlightened masters, mentors and church leaders. It is troubling. Choice sections of scripture are often being randomly used to edify, justify or debilitate another. Coming from the wrong people, even if they are well intentioned, they are also turning people away, rather than bringing people to any real meaning or understanding of life.

It appears Christianity within the United Kingdom has never been so mixed up, so confusing, and so hypocritical as it is today. If people have lost all respect for Christianity, and are moving away from it, it is some of the religious leaders of our day and the church itself which has also encouraged and enforced that viewpoint.

# Brexit, England's Independence Day

Today, 24th June, I had to visit one of the poorest towns in urban England. It is a yearly trip I always slightly dread.

This once busy little market town which was once also part of the thriving centre of the steel industry now resembles one of those Wild West scenes, where, when a stranger comes to town, the people all vanish. It's a town you wouldn't want to visit, or even want to drive through. The shops are boarded up. Litter is strewn across the streets. The buildings are grey, damp and crumbling, and dark hooded figures lurk in the side streets. Who they might be you just cannot tell. It is a world away from the place I once knew.

However, today was different. The sun was shining, the air felt fresher, and somehow this crumbling little town just didn't feel so neglected.

After pulling up at the front of the shop I was visiting, the owner came to quickly unlock the door to let me in. In recent years she has had to lock the door to stop people blatantly walking in and openly stealing her goods. There are no local policemen any more casually walking our streets, once known as the friendly local bobby. You knew their name back then, you saw them daily, and they were well respected. Local councils, once the servant of the people who had voted them in, have slowly and strangely morphed into our new law enforcers. We are answerable to them.

I made a quick dash.....

Inside, were some of the local stalwarts of the community. The ones who never left. They are what you would affectionately call the salt of the earth. They have character. In this particular part of the country they say it as it is. It quickly transpired that the dreaded trip would turn into a conversation of optimism and enthusiasm instead of the usual dark complaints. Here, the place was buzzing with the good news that Brexit had won. The UK was leaving the EU.

One of the men in the shop was an elderly Asian man. He was so excited. "Let's make Britain great again he enthused. I was

born and bred here and I want my country back" I wanted to hug him.

There was another man with his young son, and he had a great big beaming smile across his face and sparkling eyes. He looked alive. He couldn't believe, just like me, that the news would be so positive. He was hoping there would be more jobs for British workers, more respect for skilled tradesmen, and more controlled restrictions on immigration.

It had been a long time since I had heard such enthusiasm.

Suddenly, you could sense a genuine feeling of encouragement and independence, yet also a sense of belonging and family, as we all stood there amidst the ruins of the landscape.

For me, there was a restored sense of reassurance as you came to realize that the majority of British people had woken up and wanted to choose their own destiny above the intimidation of a political establishment who they didn't even know. They had been down, but not out. The people had spoken.

In the run up to the referendum, negative propaganda had been consistently used, instead of fact, to instigate fear towards the electorate.

One example was of that surrounding the sad murder and death of MP Jo Cox who was recently killed on a Leeds street by a man with mental health problems. Hailed as a 'hate crime' by some of the media, and a crime that should be fought against, it was apparent that it was being covertly aimed against people who wanted to leave the EU, in relation to Jo Cox's political stance on remaining.

It was very unfortunate that the majority of people who were genuinely sad and shocked by this crime were targeted, for they are also some of the ones who live amidst the reality of the streets where you have to watch your back every day, and where violence and crime are prevalent on a daily basis. They

too desperately want hatred to stop. They have seen first hand what happens when your life is controlled by a force you cannot see, protect yourself from, or put a name to.

## The Great Divide

In terms of discussing politics, the British can sometimes be quite reserved and secretive. We rarely ask each other who the other is voting for. A bit like religion, it is not the done thing.

But the battle between Brexit and Remain has been different, and people have felt more convicted to vote in this referendum. Never before have I ever heard of so many people passionately and openly put their own personal point across.

At every available opportunity people have been vehemently encouraging each other to either stay or leave the EU, with an emphasis on those who wanted to stay making the most lengthy and I have to say, patronizing of statements, in my own particular view.

Expert opinions abounded from the Remain campaign. Their website featured statements from such people as Stephen Hawking, Richard Branson and Sir Allan Sugar, together with opinions from 150 top scientists and 300 historians. There were also comments from the Director of Europol and numerous world leaders. They included Barrack Obama, Angela Merkel, and my favourite, Bill Clinton.

And who can forget the apparent two finger salute and the abuse that Bob Geldof made to fishermen who were campaigning for Brexit on the River Thames.

However, June 24th, 2016, now called Independence Day, will go down in history and it has been an interesting event to witness and be part of in terms of how the human spirit still strives to retain and value the very real nature of what constitutes freedom from dictatorship, and the genuine unity and respect which can result when people are allowed to live by their own convictions, and finally have their own voices heard.

It sounds wonderful doesn't it? But like the sinking of the Titanic, although the ships going down, hope still floats. There is a love element, which is why the movie is also called a chick flick. In this particular story, the man gets his girl, the girl gets her man, the children get parents, and they all move on.

Affairs of the heart sometimes appear like that. Yes, we have to move on, but life often deals with change in a very superficial and romantic way. Happy after afters often leave untold stories of confusion and grief. We have to muster up an awful lot of forgiveness.

People who believe they are in positions of power can be adept at looking over the real harm they create.

With the cultural and social shifts which we witness in attitudes towards marriage, family, gender, religion and

abortion, it is clear to see that unless you have the correct information, genuine hope, the willingness to overcome your problems, and a love for doing the right thing, life can step over and crumble so many of those untold stories. In 2015, it is reported the Lord Chancellor, Michelle Grove and the Lord Chief Justice, Lord Thomas of Cwmgiedd barred Mr Page from sitting as a Magistrate after he had expressed his traditional views on marriage and his belief that it was in the best interests of a child to be placed in a traditional

family setting rather than with a same-sex couple.

Mr Page is quoted as saying "This is not a matter of prejudice or bigotry but is based on knowledge and evidence that I have applied when seeking the best interests for a lifetime of a vulnerable child"

Felix Ngole is a Christian student who has been expelled from the University of Sheffield after he expressing his support for American, Kim Davies in a face book discussion in which he explained biblical teaching on sexual ethics. It is reported that; The Faculty of Social Sciences Fitness to Practice Committee for the university ruled that he should be removed from the course. This has meant he will no longer be able to pursue his chosen vocation as a social worker.

It can only be a biased system that chooses to edify the struggle of the single mother at the expense of the many fathers who love and raise their children too. But we hear so little about them.

Why.

## British children manipulated and robbed of their innocence

Through a Glass Darkly

If you look through this type of lens, you could say there are really more people in that meeting if you honestly looked. For

It is reported that the survey was later withdrawn for amendments, yet not abolished, after the Children's Commissioner, Anne Longfield received complaints.

Distorted animals called superlamanana are strange sculptures that have been appearing all over Liverpool. They are intended to be a representation of a cross between a banana and a lamb. There is The Willow Man in Bridgewater, Somerset, the largest willow figure in the UK, meant to represent the willow industry of the area but identical to the Wicker man effigies used by ancient druids for pagan sacrifice. I have passed this sculpture many times and it is a disturbing distraction located alongside the main M5 motorway where most tourists travel to holiday destinations.

In Plymouth, there is a large ugly sculpture of a mythical sea creature nicknamed The Prawn on the Barbie, located near The Barbican Centre in the place where the Pilgrim Fathers left for their pilgrimage to America. In Ilfracombe in Devon, there is Verity, created by Damien Hurst who refers to his work as a modern allegory of truth and justice. The statue is of a pregnant woman holding a sword and standing on a pile of law books and is reported to be the largest sculpture in the UK. The sculpture shows the internal anatomy of the woman with the foetus visible. The face is ugly, and part of the leg is peeled away. It is a disturbing piece of work located on a beautiful landscape. What is the point of all of these disturbing images and is it any coincidence that it is becoming impossible to avoid being exposed to such disturbing imagery and altered perceptions?

Note: A beautiful painting called The Sun was painted in 1909. It is a painting of a sun-covered sky and it is described as all-pervasive, shining from the heavens upon land and sea, reaching out to all eternity, pure in image, intense. It was painted by Edward Munch who painted The Scream in 1893.

Were glimpses of heaven given to Edward Munch who was disturbed by horrifying visions and nightmares. I wonder.
