Reserves

“The reserves are the nation’s second line of defense. The reserve component is made of two elements: the National Guard and the reserves. The component is made up of both part-time and full-time service members and civilian Title 5 employees. Currently, all branches have a reserve component except for the Space Force...

National Guard

“The National Guard is the second arm of the reserve component and consists of both the Army and Air Force. Similar to the reserves, members of the National Guard, or guardsmen, are trained and ready to defend the nation during times of war, *threats to national security and national emergencies*. *However, the National Guard is also called up for state emergencies. Because of this, and contrary to the reserves, the National Guard reports to both the state and federal government.*

“The National Guard serves at the behest of a state governor and the president of the United States. During local emergencies, the governor can activate the National Guard on state orders, without prior presidential approval. ***However, in***

some instances, the president can mobilize a state's National Guard without prior consent of the governor." Rest at link. Mayors are not governors.

“Under the United States Constitution and congressional practice, Members of Congress may have their services ended prior to the normal expiration of their constitutionally established terms of office by their resignation or death, or by action of the house of Congress in which they are a Member by way of an “expulsion,” or by a finding that in accepting a subsequent “incompatible” public office, the Member would be deemed to have vacated his congressional seat.

“Under Article I, Section 5, clause 2, of the Constitution, a Member of Congress may be removed from office before the normal expiration of his or her constitutional term by an “expulsion” from the Senate (if a Senator) or from the House of Representatives (if a Representative) upon a formal vote on a resolution agreed to by two-thirds of the Members of that body present and voting.

“While there are no specific grounds for an expulsion expressed in the Constitution, **expulsion actions in both the House and the Senate have generally concerned cases of perceived disloyalty to the United States**, or the conviction of a criminal statutory offense which involved abuse of one's official position. Each house has broad authority as to the grounds, nature, timing, and procedure for an expulsion of a

Member.

“However, policy considerations, as opposed to questions of authority, have appeared to restrain the Senate and House in the exercise of expulsion when it might be considered as infringing on the electoral process, such as when the electorate knew of the past misconduct under consideration and still elected or re-elected the Member.”

I am not a lawyer and have no legal training but I know how to read and comprehend content. MEMORANDUM FOR THE SECRETARY OF DEFENSE, THE ATTORNEY GENERAL & THE SECRETARY OF HOMELAND SECURITY

SUBJECT: Department of Defense Security for the Protection of Department of Homeland Security Functions

“Numerous incidents of violence and disorder have recently occurred and threaten to continue in response to the enforcement of Federal law by U.S. Immigration and Customs Enforcement (ICE) and other United States Government personnel

who are performing Federal functions and supporting the faithful execution of Federal immigration laws.

“In addition, violent protests threaten the security of and significant damage to Federal immigration detention facilities and other Federal property. To the extent that protests or acts of violence directly inhibit the execution of the laws, they constitute a form of rebellion against the authority of the Government of the United States.

“In light of these incidents and credible threats of continued violence, by the authority vested in me as President by the Constitution and the laws of the United States of America, I hereby call into Federal service members and units of the National Guard under 10 U.S.C. 12406 to temporarily protect ICE and other United States Government personnel who are performing Federal functions, including the enforcement of Federal law, and to protect Federal property, at locations where protests against these functions are occurring or are likely to occur based on current threat assessments and planned operations.

“Further, I direct and delegate actions as necessary for the Secretary of Defense to coordinate with the Governors of the States and the National Guard Bureau in identifying and ordering into Federal service the appropriate members and units of the National Guard under this authority. The members and units of the National Guard called into Federal service shall be at least 2,000 National Guard personnel and the duration of duty shall be for 60 days or at the discretion of the Secretary of Defense. In addition, the Secretary of Defense may employ any other members of the regular Armed Forces as necessary to augment and support the protection of Federal functions and property in any number determined appropriate in his discretion.

“To carry out this mission, the deployed military personnel may perform those military protective activities that the

Secretary of Defense determines are reasonably necessary to ensure the protection and safety of Federal personnel and property The Secretary of Defense shall consult with the Attorney General and the Secretary of Homeland Security prior to withdrawing any personnel from any location to which they are sent. The Secretaries of Defense and Homeland Security may delegate to subordinate officials of their respective Departments any of the authorities conferred upon them by this memorandum.”

Returning to the issue of taxes and how the ‘big beautiful bill’ is going to affect YOU. H.R. 5371, the “Continuing Appropriations, Agriculture, Legislative Branch, Military Construction and Veterans Affairs, and Extensions Act, 2026,” which makes continuing appropriations and extensions for fiscal year 2026, and for other purposes.” That is a good bill.
