

# Charge These Union Personnel With Obstruction For Protecting Illegals

[The Treaty of Guadalupe Hidalgo:](#) “The Treaty of Guadalupe Hidalgo, which brought an official end to the Mexican-American War (1846-1848) was signed on February 2, 1848, at Guadalupe Hidalgo, a city north of the capital where the Mexican government had fled with the advance of U.S. forces.

“The United States paid Mexico \$15,000,000 “in consideration of the extension acquired by the boundaries of the United States” (see Article XII of the treaty) and agreed to pay American citizens debts owed to them by the Mexican government (see Article XV). Other provisions included protection of property and civil rights of Mexican nationals living within the new boundaries of the United States (see Articles VIII and IX), the promise of the United States to police its boundaries (see Article XI), and compulsory arbitration of future disputes between the two countries (see Article XXI).”

Employers across this country who call themselves Americans knowingly hire illegal aliens crap in the face of millions of Americans who desperately want to work and would love to have the **millions of jobs** held by illegal aliens. All they care about is the bottom line: cheap labor.

Federal laws says ANYONE who assists in helping illegal aliens remain in this country are subject to arrest: [Illegal aliens: declaring war on the enablers](#) (I wrote that column in 2010 which shocked many because of the facts in it so I hope you'll take the time to read it.)

“It was Truman who pushed the Federal Immigration and National Act of 1952 through Congress in the closing days of his administration. Under Section 8 USC 1324[a](1)(A)[iv][b](iii) any US citizen that knowingly assists an illegal alien, provides them with employment, food, water or shelter has committed a felony. City, county or State officials that declare their jurisdictions to be “Open Cities, Counties or States are subject to arrest; as are law enforcement agencies who chose not to enforce this law. Police officers who ignore officials who violate Section 8 USC 1324[a](1)(A)[iv][b](iii) are committing a Section 274 federal felony. Furthermore, according to Federal Immigration and National Act of 1952, if you live in a city, county or State that refuses to enforce the law for whatever reason, the officials making those rules are financially liable for any crime committed within their jurisdiction by an illegal alien.”

[Here, go read the law for yourself.](#) Read those words: if you live in a city, county or State that refuses to enforce the law for whatever reason, the officials making those rules are financially liable for any crime committed within their jurisdiction by an illegal alien. Of course, there's the law for the wealthy where you or I would be in jail. Punk billionaire Facebook honcho, Mark Zuckerberg, bragged about hiring illegals. "An average of 400 "criminal illegal immigrants" are being released every 10 days by the newly elected sheriff in Arizona's most populous county, federal law enforcement sources tell Judicial Watch, many of them violent offenders. It's part of Maricopa County Sheriff Paul Penzone's new policy to protect illegal aliens, even those who have committed serious state crimes, from deportation. Under a longtime partnership between the county and the feds, the Phoenix field office of Immigration and Customs Enforcement (ICE) was notified when "aliens unlawfully present with additional Arizona charges" were released from the Maricopa County Jail, which is one of the nation's largest with a population of about 8,000." Penzone replaced Sheriff Joe Arpaio after the election last November.

Now, some companies have been fined which is great: [Tree company Asplundh to pay largest fine ever for hiring undocumented workers](#), September 29, 2017:

"A tree-trimming company that is one of the largest privately held corporations in the nation has been ordered to pay \$95 million in penalties for employing people in the United States illegally. Asplundh Tree Experts, based in Willow Grove, Pa., was ordered Thursday to pay the huge fine by a federal judge sitting in Philadelphia, the U.S. Attorney's Office for

Eastern Pennsylvania said. In addition to having to forfeit \$80 million, Asplundh will pay a \$15 million civil penalty for not complying with immigration law.”

And, I’m ecstatic over this because money means nothing to most scum bag employers who hire illegals. Maybe time in the slammer will finally send a strong message – you’re next:

[Feds Sentence Waste Management Supervisors for Hiring Illegal Workers](#), April 3, 2017 – “A jury convicted Rudy Alexander Martinez, 36, and Israel Arquimides Martinez, 44 on April 8, 2016, after a trial that lasted two weeks and about six hours of deliberation. The jury determined the two Salvadoran nationals conspired to employ and actually employed illegal aliens, according to information obtained from U.S. Immigration and Customs Enforcement officials by Breitbart Texas. Also, the jury found the defendants encouraged and induced illegal aliens to enter the country without documentation and to reside in the U.S. Finally, the jury convicted the two men on charges of aggravated identity theft—a separate offense that carries a sentence of two years which runs consecutive to any other sentencing...

“Federal Judge Melinda Harmon sentenced Rudy and Israel Martinez to serve 94 and 87 months respectively. The sentence includes the mandatory 24-month sentence for the identity theft that must run consecutively to the other sentencing. The judge ordered Arroyo to spend 27 months in federal prison for his role in the conspiracy. As Rudy and Israel Martinez are Salvadoran nationals, they will face deportation following the completion of their prison term.”

However, now unions who have no problem giving we the people the finger – the ones fleeced for hundreds of BILLIONS of BORROWED dollars to pay for the illegal’s gravy train ([The Ever-Spiraling Cost of Illegal Aliens Reached New Record in Fiscal Year 2017 – \\$135 BILLION](#)) – are going all out to aid and abet illegal aliens:

[Unions Are Training Hotel Workers to Face Down Immigration Raids](#) – Contract negotiations are a key tool to restrict hotels from collaborating with ICE.

“Hotel workers in cities such as Los Angeles, Chicago, and New York have been gathering for training sessions recently on how to handle visits from U.S. Immigration and Customs Enforcement. The sessions, organized by the labor union [Unite Here!](#), teach workers how to effectively stonewall ICE agents, emphasizing employees’ right to refuse to answer questions or show identification.”

In other words, labor unions like Unite Here! don’t give a damn about our immigration laws, all they care about is building numbers – from the same link above: “Immigration has historically been a [thorny issue](#) for labor unions, which often took a much harder line in the name of protecting native workers. That position has shifted dramatically in recent decades, as organizing the growing ranks of immigrant workers became a do-or-die proposition for shrinking unions. “There was a recognition on the part of the labor movement that it’s too late to kick people out, so we have to organize them,” says Janice Fine, a Rutgers University labor expert. “The labor movement as a whole has probably never been more pro-immigrant.”

Each of the individuals who either run that union or their lackeys are guilty of violating the Federal Immigration and National Act of 1952 and need to be arrested by the Federal Department of Justice to continue sending a strong message: How good do you look in prison stripes?
