Trump CAN Bring Her to DC, It Is Believed

Last year, Colorado Communists “threw the book” at Mesa County Clerk, Tina Peters because she was witness to the theft of our 2020 Election. Today, Tina Peters was sent to solitary confinement in a windowless cell at the Colorado prison where she is being held, because she filed a simple grievance with prison authorities. Although President Trump cannot pardon Tina because hers were not federal offenses, according to Brian Kennedy, senior fellow at the Claremont Institute and Chair of the Committee on the Present Danger: China, in his statement on X, the President CAN. Trump, as Chief magistrate, can send federal

officials into the Colorado prison, and bring Tina Peters back to DC as a witness to the stolen 2020 election. There is a federal custodial witness protection program which supersedes Colorado law. There are strong national security implications in what Tina knows.

Kennedy advises that the feds bring her back to DC from Colorado, keep her in far more humane custody, and have her testify about what she knows.

Tina's "crime" was to have kept possession of certain reports from the voting machines – the crooked voting machines in her county – which proved the malfeasance of state election officials. Yes, she was not to have kept them, but she wanted to show the shockingly illegal operations.
