Gavin Newsom's Court Claims: In response to a lawsuit from over 3,000 Palisades residents . . . Governor Newsom's office denied state responsibility, claiming the fire was arson-related and that the state had no notice or duty to respond/monitor. – New Contradictory Evidence from LAFD Records: Los Angeles Fire Department incident reports reveal the LAFD notified the state just after midnight on January 1; the state sent a park representative at 1:46 AM, who arrived on scene by 4:00 AM. – California was heavily involved on the scene: A state park representative was present near the burn scar, ordering firefighters on where they could and could not go (e.g., prohibiting bulldozing to put out embers. on January 2). Another representative arrived the next day. – Documents show California mismanaged the fire and now Gavin Newsom is outright lying about it and covering up the evidence in court

That Newsom would lie is a given, but with liabilities in the \$100+ billion range, he is having to shovel more than his usual bull. So, California found themselves a perp.
