## [350 Congolese Migrants Arrive in San Antonio, June 8, 2019](#)

“South and central African migrants began illegally crossing the South Texas border on May 30 when [117 migrants](#) from the Republic of the Congo, the Democratic Republic of the Congo, and Angola crossed in the Del Rio Sector. By June 5, more than 500 African migrants had crossed illegally in this single Border Patrol sector, Breitbart News [reported](#).

“In a press call on Wednesday afternoon, Brian Hastings, U.S. Border Patrol Chief of Law Enforcement Operations, told reporters this was the first large group “ever recorded in Border Patrol history solely from Central and South Africa. We’ve never seen that demographic in a large group of that size before.”

“Two weeks before the illegal crossings began in the Del Rio Sector, hundreds of African migrants gathered near an international bridge in Nuevo Laredo, Tamaulipas, to protest not being allowed entry into the U.S. through a legal port of entry, Breitbart News [reported](#).”

**They are not migrants, they are illegal aliens, period.** They have no right to be on U.S. soil and they sure as hell should not be shipped anywhere but back across the border and let Mexico deal with them. They should all have been quarantined and then shipped right back across the border.

- Genetic studies of the virus indicate that, in or about 1966, HIV first arrived in the Americas, infecting one person in Haiti. At this time, many Haitians were working in Congo, providing the opportunity for infection. [10] [[Medical citation Needed](#)]

1980

- April 24, San Francisco resident Ken Horne is reported to the Center for Disease Control with [Kaposi's sarcoma](#) (KS). Later in 1981, the CDC would retroactively identify him as the first patient of the AIDS epidemic in the US. He was also suffering from [Cryptococcus](#).<sup>[</sup>

- May 18, Lawrence Mass becomes the first journalist in the world to write about the epidemic, in the [New York Native](#), a gay newspaper. A gay tipster overheard his physician mention that some gay men were being treated in intensive-care units in New York City for a strange pneumonia. "Disease Rumors Largely Unfounded" was the headline of Mass's article.<sup>[20]</sup> Mass repeated a New York City public-health official's claims that there was no wave of disease sweeping through the gay community. At this point, however, the [Centers for Disease Control](#) (CDC) had been gathering information for about a month on the outbreak that Mass's source dismissed. [[Citation Needed](#)]
- June 5, The CDC reports a cluster of [Pneumocystis pneumonia](#) in five [gay](#) men in [Los Angeles](#).<sup>[21]</sup>
- July 3, An article in [The New York Times](#) carries the headline: "Rare Cancer Seen in 41 Homosexuals". The article describes cases of Kaposi's sarcoma found in forty-one gay men in New York City and San Francisco.<sup>[22]</sup>
- July 4, The CDC reports clusters of Kaposi's sarcoma and [Pneumocystis pneumonia](#) among gay men in [California](#) and [New York City](#).

Kaposi's sarcoma "became more widely known as one of the [AIDS-](#)

[defining illnesses](#) in the 1980s”.

Instead of being quarantined, those poor souls who all died were “treated” at hospitals and sent on their way. The disease then became an inferno.

What Americans might not be aware of is this very real threat what would make the AIDS/HIV epidemic look like an outbreak of the measles.

[The world’s second-biggest Ebola outbreak is still raging](#), May 24, 2019

“An [Ebola epidemic](#) thundering through heavily populated provinces in the [northeastern Democratic Republic of the Congo](#) has sickened [1,877 people and killed 1,248](#) as of May 22, according to the World Health Organization—despite the efforts of specialist medical teams, an effective vaccine, and new treatments that are being tested in the region.

“The outbreak already is the second-largest on record, behind the epidemic that burned through West Africa from 2014 to 2016, killing more than [11,300 people](#). In its most extreme form, the viral hemorrhagic fever leads to uncontrollable bleeding and death.”

Ebola can and does spread like a raging wildfire. It’s a horrible, horrible way to die. More from the article above:

“But [transmitting Ebola](#) is not exactly simple: The virus travels between humans through infected bodily fluids and tissues, but infiltrating a second host requires going in through broken skin or a mucous membrane, such as the eyes or nose.”

While there is a large number of articles which all claim Ebola is not airborne, I wouldn’t bet my money on it:

[Ebola Virus Could Mutate And Become Airborne: Danger For Cross Species Transmission](#)

“New research out of Canada has found a scary possibility: Ebola could become airborne. The testing was done by The Public Health Agency of Canada, together with the Canadian Food Inspection Agency, and led by Dr. Gary Kobinger.

“The researchers used an experiment with pigs and monkeys. The pigs carried the virus and were placed in a room with wire mesh separating them from the monkeys. The animals were not able to touch each other. After eight days, a selection of the monkeys showed signs of Ebola infection.

“This result shows that the Ebola virus was able to be passed through the air and that it was capable of cross species transmission. The Ebola virus was passed from the pigs via liquid particles through the air. The virus would not be able to through the air in long distances.”

Instead of dumping these illegal aliens into cities they should all be quarantined. Oh, no. Let’s dump them out into the general population. Thankfully schools are out for summer so illegal minors with snotty noses don’t have contact with any other students and faculty.

### [Ebola Incubation Period](#)

“The Ebola incubation period is the period between infection with the virus and the appearance of symptoms associated with the disease. The incubation period can be as short as 2 days or as long as 21 days. A person is still contagious during this time.

“What Is the Incubation Period for Ebola? When a person becomes infected with [the Ebola virus](#), it enters the body and begins to multiply.

“Is a Person Contagious During the Ebola Incubation Period?

“Even if a person exhibits no signs or symptoms of Ebola, he or she can still spread the virus during the incubation

period. Once symptoms begin, the person can remain contagious for about three more weeks.”

[Texas nurse who contracted Ebola settles hospital lawsuit](#), Oct.24, 2016

“A Texas nurse who contracted Ebola while treating a patient has settled a lawsuit against the hospital where she became

infected. The diagnosis of Nina Pham was the [first known transmission](#) of the disease in the United States...

**“Pham and another nurse contracted Ebola in October 2014 after treating Thomas Eric Duncan, who started showing symptoms after arriving in Dallas from Liberia.**

“Pham wore a mask, gown, shield and gloves, but it wasn’t enough. Two days after Duncan died, Pham was diagnosed, despite assurances from her employer that she was at no risk for Ebola and could “freely” see friends and family, the lawsuit contends.”

Liberia located on the West African coast a good distance from Cameroon and Angola. Duncan got off a plane in Dallas carrying a deadly, highly contagious almost always fatal disease. [“Duncan contracted the disease in his home country of Liberia](#) after neighbors said he helped take a woman dying of Ebola to the hospital. Officials have said Duncan did not disclose having contact with an Ebola patient before he flew to Dallas to visit family members.”

500 illegals from the Congo just got dumped into San Antonio. San Antonio’s population is 1,511,946. Is your city next? It will only take one good outbreak for this to spread like wildfire. [Woman spread Ebola virus one year after infection, doctors say](#), July 4, 2018



LONDON (AP) –" A Liberian woman who probably caught Ebola in 2014 may have infected three relatives a year after she first fell sick, doctors reported in a study published Monday.

"There have been previous instances of men spreading Ebola to women via sexual transmission – **the virus can survive in semen for more than a year** – but the new case is the first time scientists have suggested that Ebola was spread from a woman after such a prolonged period."

Back in 2014 there were only a few Level-4 Biocontainment units in the U.S.:

[There are only 19 level 4 bio-containment beds in the whole of the United States...and four in the UK](#)

"I think we just found out why the government(s) are underplaying the situation. They simply do not have the facilities to cope with even a small outbreak. They are, in fact in exactly the same position as the dirt-poor hospitals in West Africa...there are not enough facilities to stop the spread of the disease if it gets out. The quality of care is better, but the availability of containment most likely isn't."

"Texas is creating two new biocontainment facilities for treating possible future Ebola patients, one in Richardson and the other in Galveston, Gov. Rick Perry announced Tuesday, as two Dallas nurses remain hospitalized out of state with the potentially deadly virus."

I found the Galveston facility has a whopping six beds. I could not find a number for the one in Richardson which is a small town of about 106,000.

Let's speculate for a moment that 50 of the 500 illegals from the Congo are single men who have sex with some woman, maybe a
