Wray was born in New York City and graduated from Yale University in 1989 and got his law degree from Yale Law School in 1992. Wray worked alongside James Comey and former FBI director Robert Mueller at the Justice Department during his time with the FBI.

Wray was nominated by President George W. Bush in 2003 as Assistant U.S. Attorney for the Criminal Division. Thus, it is only logical to wonder if he is also a member of Yale's Skull and Bones.
