

Government “Will Be The Death Of Us Yet”



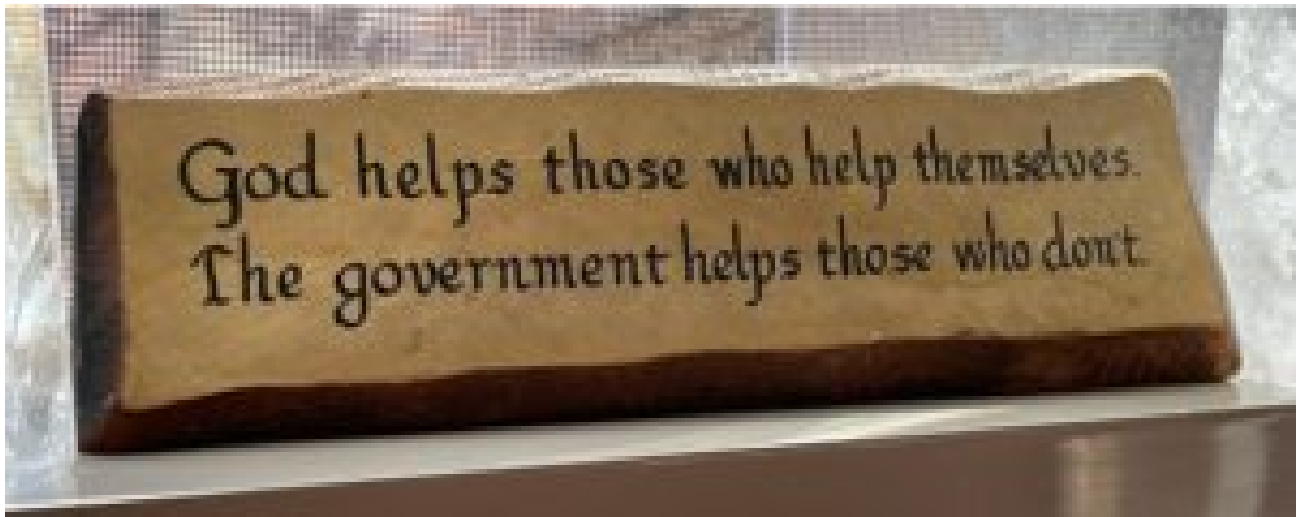
