

# ICE Raids: Arrest These Elected Officials Obstructing Lawful Enforcement

ICE is Immigration and Customs Enforcement under the Department of Homeland Security:

“ICE’S mission is to protect America from the cross-border crime and illegal immigration that threaten national security and public safety.

“This mission is executed through the enforcement of more than 400 federal statutes and focuses on smart immigration enforcement, preventing terrorism and combating the illegal movement of people and goods.”

“Immigration and Customs Enforcement (ICE) has confirmed to *Prairie State Wire* that Jose Rodriguez, who struck and killed Corey Cottrell, 39, of Normal on June 22, is in the United States illegally. Border Patrol agents, in fact, issued the 27-year-old from Honduras an expedited removal order all the way back on April 17, 2013, according to a statement from ICE.

“Then on March 6, 2014, a federal immigration judge ordered him removed in absentia,” the statement said. “He is considered an ICE fugitive.”

“ICE said that it placed an immigration detainer with McLean County Jail on June 23 in light of Rodriguez’s criminal arrest.

“But the detainer is powerless since Illinois is a sanctuary state and Bloomington a sanctuary city, said Don Rosenberg of Advocates for Victims of Illegal Alien Crimes (AVIAC).

“Officials in sanctuary jurisdictions are not permitted to cooperate with ICE regardless of the crime,” said Rosenberg, a Californian whose son was struck and killed in 2010 by a car driven by someone in the country illegally.

“In 2017, Illinois became a sanctuary state for the at least 400,000 illegal aliens living in the state,” the story said. “The law shields criminal illegal aliens from being detained and deported from the U.S. In Rodriguez’s case, the state allowed him to be released on bail despite his deportation order dating back six years ago.” Corey’s funeral services were held today.”

“But not only is it bad economics, it’s also illegal under federal law. In 1996 Congress passed, and President Bill Clinton signed, a major welfare reform act. A crucial section

of that law was inserted by the Republican Congress. It prohibited states from giving public benefits to illegal aliens. And it remains in federal [law](#) today at 8 U.S.C. 1621: an illegal alien “is not eligible for any State or local public benefit.”

“Public benefit includes “any ... health ... benefit for which payments or assistance are provided to an individual, household, or family eligibility unit by an agency of a State or local government ...”.

“If the Trump Department of Justice wants to go on the offensive against states that directly violate federal law, California’s new law would be a good one to challenge. Even in the left-leaning Ninth Circuit, judges would find it difficult to come up with a reason to sustain the law when it is so directly pre-empted by federal statute.

“It’s not surprising that Governor Newsom would violate federal law without hesitation. He did the same when he was Mayor of San Francisco, maintaining and defending San Francisco’s sanctuary city ordinance, which [violates](#) 8 U.S.C. 1373(a).”

The U.S. Department of Justice needs to arrest Gavin Newsom and charge him, period. Quit pussy-footing around and show some stones, AG Barr. **No one is above the law or none of us should be required to follow any federal laws.**

“Measure M will prohibit the growing of GMO crops in Sonoma County protecting local farms, pastures, and cover crops from contamination. Because pollen cannot be contained, contamination from GMO crops has resulted in millions of dollars in lost export revenue for farmers throughout the country.

“Sonoma County’s agriculture embraces its local family farms, which are organic or non-GMO. Measure M was designed to protect their right to grow using traditional methods.

“It was endorsed by hundreds of local farmers, vintners, businesses, community organizations, and thousands of individuals across Sonoma County.

“GMOs are not delivering the promise of higher yields. Heavy



herbicide spraying is creating herbicide resistant weeds and affecting the microbial balance in the soil. Nutrient deficient soil and resistant weeds are reducing crop yields. As we begin to understand long term impacts, both consumers and farmers are moving away from GMOs. More than 35 countries prohibit growing genetically engineered crops and many have restrictions on imports.” (It is now 40)

Five years. Without the help of big media (ABC, CBS, MSNBC, FOX and others), it takes time to educate our fellow Americans on these issues. Those people sacrificed their time and likely some financial resources but they stayed at it and won.

“Almost 2 million people have submitted comments opposing the fish’s approval, spurring several major retailers including Kroger, Safeway and Target to pledge not to carry GM seafood in their stores.

## No freshwater or ocean cultivation

“The California law, AB 504, was authored by Wes Chesbro, D-Arcata, in order to protect the state’s native populations of salmon and steelhead trout, a closely related species. The law was also supported by the Pacific Coast Federation of Fishermen’s Associations.

“If these ‘frankenfish’ were to escape into our waters, they could destroy our native salmonid populations through interbreeding, competition for food and **the introduction of parasites and disease**,” Chesbro said. “The only way to ensure this never happens is to ban commercial hatchery production, cultivation or stocking of transgenic salmonids in [California](#).”

“Under the new law, no cultivation or spawning of “transgenic salmonids” will be permitted in any of California’s fresh or Pacific waters. Even research into GM salmonids is prohibited, if it is intended for commercial purposes.

“California has taken an important step to protect its native [salmon](#) and trout stocks. Genetically engineered salmon pose a serious risk to our waterways and our native fish populations,” said Rebecca Spector, West Coast Director of the CFS.”
