Pam Bondi faces 'prosecution' if 'all' Epstein files are not released ...

Gilliam believes that Trump should name a "Justice Czar" to coordinate both prosecutions and policy fixes; this, after Bondi and Patel turned over documents to Congress showing that the Mar a Lago raid was made even though the Biden Administration had been told that there was absolutely "no probable cause" for the raid.

As Gilliam told Just the News, No Noise television, "it's the same characters every time. We had a tremendous amount of evidence that they were trying to create . . . and falsify evidence to go after Trump.
