## And Here Comes Some More...

*"The violence of the wicked will [return to them and] drag them away [like fish caught in a net], Because they refuse to act with justice." -Proverbs 21:7*

When I was 14-years-old, I remember watching a martial arts movie called "Kill or Be Killed." The people listed were charged as part of the Feeding Our Future fraud scheme in Minnesota, which is a federal case that involves theft of \$250 million from child nutrition programs during COVID.

All were indicted for submitting fraudulent meal claims, laundering funds, and bribery.

The scheme involved fake nonprofits claiming to serve millions of meals to children.

Up to this point, there have been no impeachment proceedings or prosecutions brought against Keith Ellison.

The people are told that he was voted in just like Tim Walz. They are not being voted into office. They are being installed.
