

# Rebuttal: Nullification Is A Fake Solution

[New ATF Regulations](#), April 4, 2022: “Last year the Montana state legislature enacted a law banning the enforcement by local or state officials of any federal gun control existing or implemented after January 1, 2021. With the law in effect since April 2021, it is now poised to undermine the planned implementation of at least two new unconstitutional federal gun control regulations.

“Per President Joe Biden’s executive orders, the Bureau of Alcohol, Tobacco, Firearms, and Explosives (ATF) is preparing to formally adopt two new rules. One will require the registration of 80 percent lowers, which are unfinished firearm parts that you can use to build your own gun.

“The second will impose federal regulations on pistol braces. These devices serve as a stabilizer that enables a shooter to fire with one hand. Pistol braces are popular with disabled people who can’t use both arms. But the feds claim they are a dangerous firearm accessory. There are an estimated 40 million pistol braces in private ownership, with no grandfather clause allowing their owners to keep them without reporting it to the feds.

“The feds lack the constitutional authority to regulate either of these firearm accessories. Nevertheless, they are preparing to do so anyway. But for those new regulations to have any meaning, they need to be enforced.

“That’s where the Montana law comes in. The law employs a legal principle known as anti-commandeering or a “refusal to cooperate with officers of the Union,” as James Madison put it in Federalist #46. As Mike Maharrey noted in his report on the law:” (Rest at link above.)

**Here’s what prompted me to write this rebuttal:**

“Ever since the rise of Tea Party and Liberty groups following the 2008 elections, these groups have proposed “State Nullification” as a solution for unconstitutional federal overreaches of authority. Like fake solution #1, this idea has been tried many times over the years, failing every time.”

While I fully support marijuana for medicinal purposes with fully informed warnings, I am absolutely against it for “recreational use”. Federal law to this day still classifies “weed” under the Controlled Substance Act as a Schedule 1 substance. In effect, those states have opposed federal law including enforcement as if the federal law doesn’t exist.

However, in that example, those states have also created a legal problem regarding banking rules and regulations. Any financial institution that provides services to pot businesses from opening accounts, credit cards and so forth is at substantial risk. That of course has kept the pot industry a cash business, also very risky. Not to mention the big increase in vehicle accidents, so many fatal.

“Any act or set of acts which results in a particular federal law or program being rendered null and void under the law, or unenforceable ***in practice***.”

“Thomas Jefferson and James Madison first **formalized** the

principles of nullification in the Kentucky and Virginia Resolutions of 1798. While Jefferson called it “the rightful remedy” to federal overreach, Madison put it a different way, saying a state is “duty bound” to interpose “to arrest the progress of the evil.”

“Jefferson and Madison were the first to propose nullification specifically, but they didn’t create the idea. In fact, the strategies and principles date back to before the American Revolution. Colonists used nullification strategies to force Parliament to repeal the Stamp Act. And during the Virginia ratifying convention, George Nicholas said that if Congress were to exercise any power not expressly granted to it, the state of Virginia would be “exonerated from it,” implying that the state would have the authority to ignore or block unconstitutional acts.

“Nullification is a fundamental part of the American political system. But what exactly does it mean? There are two definitions. One is legal. When a court strikes down a law, it literally wipes it off the books. But there is also a practical definition – to make something of no value or consequence. When we talk about nullification happening today, we generally mean it in the practical sense – to end the practical effect of a federal act.

“Here is a succinct definition of nullification as we apply it: *Any act or set of acts which has as its result a particular law being rendered legally null and void, or unenforceable **in practice**.* Madison gave us a blueprint on how to do this in *Federalist #46*. He suggested four steps to take on counteract and stop federal programs – whether “warrantable” or “unwarrantable,” the most significant being a “refusal to cooperate with officers of the Union.”

“The federal government involves itself in almost every aspect of life, but depends on state assistance to do almost everything. If states refuse to help, it becomes nearly

impossible for the feds to enforce their laws or implement their programs. We can use this strategy to undermine and nullify all kinds of federal acts in practice – from warrantless spying, to gun control, to plant prohibition and more.”

### [Nullifying the Stamp Act](#) – History

The Tenth Amendment Center has an entire section devoted to nullification including this: [Anti-Commandeering: An overview of five major Supreme Court cases](#). I looked up those cases; it’s a load of reading but well worth the time.

Nullification isn’t some flaky idea pulled out of thin air by a bunch of arm-chair conspiracy theorists. Far from being a “fake solution”, I stand by my support for nullification.

My late mother who died two years ago this afternoon always used to say, try and try again until you succeed. We are in a cold war with the liars and crooks in Congress as well as most of our state legislatures and governors. “And if the debt ceiling is not raised, the federal government could run out of money to pay all its bills by June. “The Treasury Department already began some extraordinary measures to keep paying the government’s bills last week, including suspending investments for selected government accounts.

“In a letter to Congress, Treasury Secretary Janet Yellen warned that there is “considerable uncertainty” around how long these extraordinary measures could be effective. “I

respectfully urge Congress to act promptly to protect the full faith and credit of the United States,” Yellen said in the letter sent last week.

“On the \$1 trillion platinum coin loophole, which potentially allows the Treasury Department to mint platinum coins of any denomination and deposit them at the Federal Reserve in exchange for the U.S. federal debt, Yellen was very skeptical.

“In an interview with The Wall Street Journal, Yellen said that the Federal Reserve is unlikely to agree to such a plan, calling the scheme a “gimmick.”

“It truly is not by any means to be taken as a given that the Fed would do it, and I think especially with something that’s a gimmick,” she said in an interview published Sunday. “The Fed is not required to accept it, there’s no requirement on the part of the Fed. It’s up to them what to do.”

“Assuming Secretary Yellen’s statements about debt were correct, the best prospect of the debt issues outside the U.S. would be the U.S. Treasury Department solving the U.S.’ own domestic debt problem, given how well she knows about facts, her professional capacities and her team’s implementation ability,” The Chinese Embassy in Zambia said on Tuesday.”

“We were having these conversations with Jack Lew [the treasury secretary at the time] and others about what options in fact were available, because it had never happened before,” Obama said. “There were all kinds of wacky ideas about how potentially you could have this massive coin.”

“Obama described imagining a very large coin. “It was some primitive ... it was out of the Stone Age,” Obama said. “I pictured rolling in some coin.” But it doesn’t have to be a giant coin because it doesn’t technically have to be made out of \$1 trillion worth of platinum.

“The U.S. is not on a gold or platinum standard. And even though the coin will require some platinum to be used, it can be as small as a dime, with the U.S. Treasury assigning any value to it, including \$1 trillion...

“Like this is the parody version of #MTFC. Coin doesn’t have to be massive. Just needs to platinum and have \$1 trillion printed on it,” co-host of the Odd Lots podcast Joe Weisenthal tweeted back in 2017.”
