

# Rogue sheriff: indict and arrest her

Gov. Greg Abbott [R-TX] has been in a highly publicized war with a rogue sheriff here in Texas who protects illegal aliens. Sheriff Hernandez is a disgrace to the uniform and oath of office she took when elected. Her territory includes Austin, a major metro area.

“Travis Co. Sheriff Sally Hernandez is facing removal from office after defying Texas Gov. Greg Abbott’s call to end “sanctuary city” policies which aid criminal aliens...

“First, you claim you have no legal power to comply with ICE detainers. That proves too much, of course, because by your own admission, Travis County Sheriff’s Office will honor some ICE detainers, for example when the alien is charged with or convicted of capital murder,” Abbott wrote. “You have the exact same legal authority to honor ICE detainers for capital murder cases as you do for other crimes that you personally deem unworthy of enforcement.”

“...Under your reckless policy, for example, dangerous criminal aliens convicted of felonies like murder, aggravated assault, human trafficking, including child sex trafficking, aggravated kidnapping, including sexual performance by a child or indecency with a child, dangerous gang activities...,” he added.”

True to his word, last week Abbott cut off a huge chunk of funding because a female sheriff, who gave our governor the finger, refuses to uphold the law putting everyone – not only in this state but around the country – in harm’s way.

Sheriff Hernandez is a selfish political animal who thinks just because she wears a badge she is above the law. Hernandez doesn't believe in cooperating with ICE detainers for illegal aliens unless it's a crime she approves of. Perhaps that miscreant should look at what her precious illegals have done in our state:

"An internal report by the Texas Department of Public Safety obtained by [PJ Media](#) reveals that over a span of about 6 years, illegal immigrants in the state committed over 600,000 crimes and were involved in nearly 3,000 homicides.

"According to PJ Media, the Texas DPS report found that from October 2008 to April 2014, **177,588 "unique criminal alien defendants"** were booked and committed 611,234 unique crimes, including 2,993 murders:

"From October 2008 to April 2014, Texas identified a total 177,588 unique criminal alien defendants booked into Texas county jails. These individuals have been identified through the Secure Communities initiative, in which Texas has participated since October 2008. A review of these 177,588 defendants shows that they are responsible for at least 611,234 individual criminal charges over their criminal careers, including **2,993 homicides and 7,695 sexual assaults.**"

Despite the gargantuan burden placed on our courts here in Texas caused by illegal aliens who claim to have rights under OUR constitution, along with raping we the people to pay for her precious illegals, Hernandez has done the unthinkable:

"Despite the loss of state law enforcement grants, Travis County Sheriff Sally Hernandez followed through and released

39 criminal aliens during the first two days of her sanctuary policy.

“Records obtained by Breitbart Texas from the Travis County Sheriff’s Office revealed that “Sanctuary Sally” released 37 criminal aliens from custody on February 1. Two more criminal aliens were released on the following day. The sheriff’s office stated that Sheriff Hernandez declined 191 immigration detainers that were received by her office before February 1.

“Eight more immigration detainers received after February 1 were also declined. The sheriff also declined four requests from immigration officials to be notified of the pending release of the criminal aliens in her custody.”

Sheriff Hernandez, just sworn in last month who could pass as a double for the Pillsbury Doughboy (How did she pass a weight test? I guess chasing down a suspect could be executed by simply rolling herself along like a barrel.), said she would only detain if “the suspect is charged with murder, aggravated sexual assault or human trafficking.”

So, if you are the victim of a robbery, home invasion, ‘simple assault’, attempted murder, kidnapping or any other crime by an illegal alien, well, tough luck. If you live in Travis County, Texas, your local joke of a sheriff (elected by an increasing number of mentally ill liberals taking over Austin) doesn’t care because she just released 39 designated CRIMINAL illegal aliens out onto the street. Will all those criminal aliens stick around the Austin area? Maybe. Or just maybe, they might be heading to your town or city.

Gov. Abbott has threatened to remove Sheriff Hernandez, but since she is an elected official I’m not sure he can do that. I do know our Republican controlled legislature is working on legislation right now to shut down every damn phony sanctuary city in this state and if possible, legislation to remove Hernandez and others like her from office.

Now, two things. First, think Kathleen Steinle in San Francisco. The illegal who killed her had been deported five times and had seven felony convictions. The City of Sodom had been protecting that illegal alien from Mexico.

“It was Truman who pushed the Federal Immigration and National Act of 1952 through Congress in the closing days of his administration. Under Section 8 USC 1324[a](1)(A)[iv][b](iii) any US citizen that knowingly assists an illegal alien, provides them with employment, food, water or shelter has committed a felony. City, county or State officials that declare their jurisdictions to be “Open Cities, Counties or States are subject to arrest; as are law enforcement agencies who chose not to enforce this law.

“Police officers who ignore officials who violate Section 8 USC 1324[a](1)(A)[iv][b](iii) are committing a Section 274 federal felony. Furthermore, according to Federal Immigration and National Act of 1952, if you live in a city, county or State that refuses to enforce the law for whatever reason, the officials making those rules are financially liable for any crime committed within their jurisdiction by an illegal alien.”

Right now we are waiting for senate confirmation for Jeff Sessions as the next Attorney General of these united States of America. Sessions has maintained a hard line against illegals for a very long time. Even if our legislature can’t

Dear Attorney General Sessions:

As you know, so-called sanctuary cities around this country are protecting illegal aliens from being deported or charged with known crimes and prosecuted. In Travis County, Texas, newly sworn in Sheriff Sally Hernandez has thumbed her nose at Gov. Greg Abbott by not only refusing to stop acting as a sanctuary city, on February 1 & 2, 2017, Hernandez released 39 KNOWN criminal aliens into the general population.

Sheriff Hernandez refuses to cooperate with ICE regarding detainers except for murder, aggravated sexual assault or human trafficking. She doesn't give a damn if those criminal illegals she's released commit other crimes like robbery, home invasion, 'simple' assault, kidnapping or any other crime against Americans – including rape or murder. She is committed to protecting illegals by aiding and abetting their ability to remain in this country illegally.

I hereby request the Department of Justice convene a federal grand jury to indict and arrest Sheriff Hernandez for violation of any and all applicable federal statutes regarding this blatant refusal to uphold the law. Aren't there enough dead Americans at the hands of illegals, not to mention women and even babies raped by illegal aliens in this country for the federal government to **crack down on the enablers?**

It's time the top law enforcement officer in this country starts making an example out of governors, mayors or sheriffs that we will NOT tolerate them or their political bias by ignoring federal laws regarding illegal aliens.

Governors and legislatures can stop funding as can Congress, but indicting and prosecuting a slew of them will send the strongest message possible: You not only won't get away with it, you will face jail time. Let the snowflakes and fairies out there demonstrate all they want. Restoring law and order in this country is LONG past due. Americans have been easy pickings long enough. Just wait until one of them is a victim of an illegal alien and see how fast they change their tune.

“A Guatemalan illegal immigrant recently received a 40-year prison sentence in Hart County Superior Court for a car crash in November that killed a Franklin County couple and their 5-year-old daughter...Ramirez was previously deported from this country, but he returned illegally and obtained a job at a plant nursery in Hart County..” That ILLEGAL ALIEN, not an immigrant, received no life threatening injuries. Sure, he was pickled in alcohol.

“In 2010, one of the illegals slaughtered my son,” said Wilkerson. “He tortured him, he beat him, he tied him up like an animal, and he set him on fire. And I am not a one-story mother. This happens every day. Because there are no laws enforcing the border. We have to start giving American families first. This is not – bad to not put Americans first,” she said. “We have family that fought and died for this country. How do you reconcile in your head about allowing people to disavow the law?” said Mrs. Wilkerson.”

“Wilkerson’s son, Joshua, died on November 16, 2010, after an illegal alien classmate brought into the U.S. as a 10-year-old beat him, strangled him, and tortured him to death, later tying him up and setting his body on fire in a field. Years later, the convicted murderer still bragged about his “killing skills” in court while [excitedly demonstrating](#) how he murdered the 100-lb. Joshua.

“Instead of getting Joshua home that day from school, we got an autopsy report,” Wilkerson [testified](#) before a Senate hearing in July 2015. “He was kicked so hard in the stomach that it sent his spleen into his spine, and sliced it in two... The medical examiner said it was torture.”

“Another American stymied in the pursuit of justice for a murdered child is [Ron Cornell](#), shown here with a car-hood portrait of his murdered son Joey. At one point, Villalobos’ whereabouts in El Salvador were known precisely, but there is no extradition cooperation with that nation either. (After the devastation
