“Nothing in the Constitution has given them [the federal judges] a right to decide for the Executive, more than to the Executive to decide for them. . . . action, but for the Legislature and Executive also in their spheres, would make the Judiciary a despotic branch.”
– (Jefferson letter to Abigail Adams, September 11, 1804, immediately following Justice Marshall’s seizure of unbridled unelected power in our courts IN 1803.)

(NOTE: However, in truth, because every federal judge must be appointed by the Chief Executive and confirmed by Congress, both “elected” branches do indeed hold ultimate power over the Judicial Branch.)

This is an all-out war over who holds the ultimate power in the USA, as it pertains to the powers of the Oval Office.

- The duly elected President and Commander-in-Chief?
- The duly elected Congress?
- The unelected Judiciary?
