

Term Limits Constitutional Amendment for Congress Fails Again

Way back in 1995, Americans across the country were fed up with the same incumbents allegedly getting reelected for 10, 20, 30, 40 years or longer as a U.S. Rep or Senator. A few years in the making, I knew any state passing a law by voters for term limits for Congress would be shot down by any higher court, but desperate, a few tried and as predicted, they all lost. The courts were right on that one.

Even though I sued the State of Texas in 2014 (Request for Write of Prohibition and injunction) to keep U.S. Senators off the ballot with PROOF the Seventeenth Amendment was NOT legally ratified (2 states short), the SoS didn't care about the truth nor did the courts. The appeals court in Austin (TX) were gutless cowards and threw my year-long case in the trash. Fraud was just fine with them. No way were they going to take on such a hot issue: A constitutional amendment that was not ratified.

It was a 'first blush' lawsuit meaning the first of its kind in either state or federal court to my knowledge – except one case on the non-ratification of the Sixteenth Amendment

(income tax). The first judge I had asked the two state attorneys how much the state was going to fine me for a “frivolous” lawsuit after he tossed my case *without reading a single document (over 300 of them)*. He damn near crapped his pants when one of the two state attorneys said the state was not going to punish me. I had been dealing with those two state attorneys for a year.

They were always very polite and had all the evidence from the National Archives, Wisconsin and California State Archives. After judge Flapdoodle stormed out of the court room I thanked them for their courtesy and for not slapping me with a big fine. While they were gentlemen to the end, they offered no comment but I believe they knew I was right. The hellish “standing” was not an issue here in Texas.

James Madison, known as the Father of the Constitution wrote: “The Senate *will be elected absolutely and exclusively by the State legislatures.*” John Jay, co-author of The Federalist Papers quoted: “Jay then informed Governor Clinton that, unlike the Senate, where the two-thirds rule was in force for treaties and impeachment, **the lower house had nothing to do with treaties; it represented the people whereas the Senate represented the states** – for the Federalists always a significant distinction.”

Back when the propaganda machine was in full swing, justification for the Seventeenth Amendment was corruption within state legislatures. Perhaps so, but only someone with their head stuck in rectal darkness can’t see how corrupt the U.S. Senate has become over the decades; very difficult to oust an incumbent senator. Always big \$\$ from special interest groups. The sovereign states of the Union have been stepped on since the fake Seventeenth Amendment became “law”. **Too many U.S. Senators have been/are owned by corporate and special interest money for decades while the average American believes their senator is representing them.**

U.S. Senators have been signing onto thousands of pieces of legislation for **unconstitutional cabinets and agencies running amok inside the states of the Union**. Large numbers of those regulations involving jurisdiction carry prison time if a conviction occurs. **When will it stop?"**

The next problem I had to address: Since ratification was two states short, Wisconsin and California, how long could the ratification process stay open? Since the Seventeenth **was two states short of ratification**, would the process still be open 101 years later?

My endless research in preparation for filing about knocked me off my chair as I found a U.S. Supreme Court case which supported my position:

[United States Supreme Court – DILLON v. GLOSS, 256 U.S. 368 \(1921\) 256 U.S. 368](#) *DILLON v. GLOSS*, Deputy Collector. No. 251. Argued March 22, 1921. Decided May 16, 1921.

"The provisions of the act which the petitioner was charged with violating and under which he was arrested (title 2, 3, 26) were by the terms of the act (title 3, 21) to be in force from and after the date when the Eighteenth Amendment should go into effect, and the latter by its own terms was to go into effect one year after being ratified. Its ratification, of which we take judicial notice, was consummated January 16, 1919. **That the Secretary of State did not proclaim its ratification until January 29, 1919, is not material, for the date of its consummation, and not that on which it is proclaimed, controls.**"

Then, much to my shock right on the heels of finding that case, what else did I discover? Oh, you won't believe this:

On April 11, **2002**, the State of Alabama decided out of the clear blue to ratify the Seventeenth Amendment – **89 years after the alleged ratification**. Back in 1913, not all states were in session; some were out of session four years at a

time. Others took no action on the amendment – Georgia specifically based on an investigation ordered by their governor at the time that the Seventeenth Amendment was not legally adopted by Congress before it was even sent to the states.

On July 1, 2010, 97 years after the alleged ratification of that amendment, the State of Delaware ratified it. On April 1, 2012, 99 years after the alleged ratification, the State of Maryland voted to ratify the Seventeenth Amendment.

How interesting that nearly 100 years after the alleged ratification of the Seventeenth Amendment and after people like me have been pounding on this issue for close to two decades, **three states just up and decided to vote on an old constitutional amendment? And why those three states?** Now you see why *Dillon v Gloss* was so important to my case as was the taxpayer ‘standing’ exception here in Texas.

Over the decades polling shows real Americans want term limits for members of Congress. Such a change requires a constitutional amendment. The big case which got shot down came in 1995: SUPREME COURT OF THE UNITED STATES – Nos. 93-1456 and 93-1828

“Today’s cases present a challenge to an amendment to the Arkansas State Constitution that prohibits the name of an otherwise eligible candidate for Congress from appearing on the general election ballot if that candidate has already served three terms in the House of Representatives or two terms in the Senate. The Arkansas Supreme Court held that the amendment violates the Federal Constitution. We agree with that holding.

“Such a state-imposed restriction is contrary to the “fundamental principle of our representative democracy,” embodied in the Constitution, that “the people should choose whom they please to govern them.” *Powell v. McCormack*, [395 U.S. 486](#), 547 (1969) (internal quotation marks omitted). Allowing individual States to adopt their own qualifications for congressional service would be inconsistent with the Framers’ vision of a uniform National Legislature representing the people of the United States. If the qualifications set forth in the text of the Constitution are to be changed, **that text must be amended.**”

Right now, it’s the deadly serious insurrection spreading by paid anarchists brainwashed into believing it’s a good thing to protect ILLEGAL aliens and unleash violence against FEDERAL ICE agents that is dominating the Internet and paid whores in the “Mockingbird media” (cable, ABC, CBS, NBC, “news” papers, etc). [Details here](#). 106 cosponsors (never thought it possible). That resolution has been rotting for nearly 10 months.

April 17, 2025 – [Senator Dave McCormick Introduces Term Limits Resolution](#)

Washington, D.C., April 10, 2025 – “Senator Dave McCormick (R-PA) introduced a joint resolution today proposing an amendment to the Constitution to implement term limits in Congress. This resolution would limit Senators to two six-year terms and House Members to six two-year terms, limiting either chamber to service of twelve years.”

Those bills will die in December because as Patrick Henry said, “I know of no way of judging of the future but by the past.”

Ten months is more than enough time to get that done and should have gotten done after Congress was sworn in last

year. **CON-gress – both House and Senate have been passing budgets with bills that are completely outside their legislative authority.** Thousands of bills for social issues; hundreds of billions of dollars to foreign countries and the list goes on; see [Art. 1 Sec. 8](#) of the U.S. Constitution. [Once again:](#)

Joseph Story, Associate Justice, U.S. Supreme Court, Commentaries on the Constitution, 1833:

“Another not unimportant consideration is that the powers of the general government will be, and indeed must be, principally employed upon **external objects**, such as war, peace, negotiations with foreign powers and foreign commerce. In its internal operations it can touch but few objects, except to introduce regulations beneficial to the commerce, intercourse and other relations, between the states, and to lay taxes for the common good. **The powers of the states, on the other hand, extend to all objects, which, in the ordinary course of affairs, concern the lives, and liberties, and property of the people, and the internal order, improvement and prosperity of the state.**”

We must also look to the Tenth Amendment: “The powers not delegated to the United States by the Constitution, nor prohibited by it to the states, are reserved to the states respectively, or to the people.”

If I were in Congress, my resolution would be 2 terms for the House (4 yrs) and one term as a Senator (6) years. Once unconstitutional cabinets (like the Federal Dept of Education) are shut down, members of Congress don't need to stay in office 20, 30 or 50+ years. Critical bills under Art. 1 Sec. 8 must be their only focus, not becoming a nanny state.

Neither CON-gress or the courts will ever come clean about the non-ratification of the Seventeenth Amendment so it will have to be amended to include term limits. Cleaning the swamp isn't

just about voting out the cockroaches who've all but destroyed this republic but also abolishing cabinets and agencies **that have zero authority under the Constitution.**
