One full year of his incarceration was served in solitary confinement...

I had the honor of baptizing Stewart at a Hear The Watchmen event in Dallas nearly a decade ago. We are friends...but not best buddies because our exploits take us different directions. But Stewart Rhodes continues to be a true, persecuted American hero.

I did an interview with Stewart Wednesday morning. It was
