

# They Are Gunning for Trump and MAGA

The law states, “(a) The holder of a permit to carry must have the permit card and a driver’s license, state identification card, or other government-issued photo identification in immediate possession at all times when carrying a pistol and must display the permit card and identification document upon lawful demand by a peace officer...”

This other would-be assassin, arrested in West Virginia, was undoubtedly inspired by the anti-Trump invective and venom emanating from the major media and its allies in the anti-ICE communist movement. Let us take a cold hard look at the case of Morgan Morrow, the “librarian” in West Virginia plotting Trump’s murder.
