## Trump Should Fire His Lawyers

## KRISTEN WELKER:

And this is the point, sir, about due process. The Constitution says every person, citizens, and non-citizens, deserve due process. Why not push to have him come back, present all of that evidence in court, let a judge decide?

## PRES. DONALD TRUMP:

Well, I'll leave that to the lawyers, and I'll leave that to the attorney general of the United States... I don't know much about this gentleman [the foreign terrorist gang member] other than I hear he's an absolute not good person. And I have very capable legal people, John Sauer, as you know, and all top people. And I have to rely on that to interpret whatever is said by the Supreme Court. Now with that being said, I have tremendous respect for the Supreme Court. Look, three of the people are people I appointed...And I have great respect for the Supreme Court. And I would expect that the attorney general will be doing the right thing.

While the Fifth Amendment's Due Process Clause applies to all "persons" within the United States, foreign nationals on American soil can be treated differently, according to America's founding fathers.

Trump has invoked the Alien Enemies Act to send them out of the country because of the presidential finding that Biden's open borders policy led to an invasion by enemy countries. That law, passed during the time of America's founding as a nation, permits summarily detaining and deporting civilians identified as enemy agents. It is up to the president, not the courts.

The liberal Brennan Center admits, "The last time the Alien Enemies Act was challenged, in *Ludecke v. Watkins* in 1948, the Supreme Court upheld President Harry S. Truman's extended reliance on the law three years after the end of World War II."

Truman was a Democrat.

The Alien Enemies Act allows the president to deport immigrants from enemy countries during a war, an attempted or threatened invasion, or a "predatory incursion" against U.S. territory. All of that is happening now.

But President Trump waits for his lawyers to win a case at the Supreme Court as the threat grows.
