#1: No one verifies citizenship of people registering to vote.

"Under current state law, it's easy for noncitizens to improperly register to vote. The process relies on an honor system – [applicants simply check a box](#) on the registration form stating they're a U.S. citizen. Once submitted, no one verifies citizenship status.

#2: State officials have failed to keep noncitizens off Texas voter rolls.

"Election integrity advocates have long called for adding citizenship safeguards to the registration system. Yet state

“For the past year, the Texas Secretary of State’s office has worked closely with the Texas Department of Public Safety (DPS) to evaluate information regarding persons identified to not be citizens of the United States. This voter registration list maintenance activity is being conducted in accordance with federal and state law to ensure that only qualified voters – [who must first and foremost be U.S. citizens](#) – are registered to vote in Texas elections.

“Through this evaluation, the Texas Secretary of State’s office discovered that a total of approximately 95,000 individuals identified by DPS as non-U.S. citizens have a matching voter registration record in Texas, approximately 58,000 of whom have voted in one or more Texas elections.”

“The voting records evaluated go back to 1996, a year after the National Voter Registration Act (also known as the “Motor Voter” law) went into effect requiring states to offer voter registration by mail-in application and as part of driver’s license applications.” Rest at link.
