Fusion centers provide an environment where the stakeholders work together to gather information, analyze data and share information to improve the ability to fight crime and terrorism locally, regionally and nationally.

Minnesota Fusion Center Mission: The mission of the Minnesota Fusion Center is to collect, evaluate, analyze and disseminate information regarding organized criminal, terrorist and all-hazards activity in Minnesota, while complying with state and federal law to ensure the rights and privacy of all.
