

# Why Countries and Some Cities Ban or Restrict 5G

From 4<sup>th</sup> graders to seniors (I taught at every school in our district), kids were seriously addicted to those phones. They were on them the minute they walked outside the classroom until they entered another. Hallways full of kids bumping into each other while blabbing on those phones.

Our school district took strict steps to make sure the only

time the kids could use them was traveling from one class to another. Over the years I've come to the conclusion that those phones have replaced interaction with real humans whether it be friends or family and in my personal opinion, that's not a good thing for society.
