Why the Hell Do Americans Put Up With This Year After Year?

The Gestapo has generously given the oxen (that would be we the people with the heavy yoke around our necks) an extra couple of days to file their federal 'income' tax return; must be post marked by midnight April 18, 2017.

You know, that massive tax deducted from your paycheck all year long and for tens of millions even more on tax filing day tomorrow.

That report is known as the Grace Commission; the formal name is President's Private Sector Survey on Cost Control which was issued on January 12, 1984. Please note the highlighted section on page 12:

"<u>Resistance to additional income taxes would be even more</u> widespread if people were aware that:

"With two-thirds of everyone's personal income tax wasted or not collected, 100% of what is collected is absorbed solely by interest on the federal debt and by Federal Government contributions to transfer payments. In other words, all individual income tax revenues are gone before one nickel is spent on the services which taxpayers expect from their government."

Those individual 'income' taxes you voluntarily pay are for what is called transfer payments. That would be the exorbitant interest paid to the unconstitutional 'Federal' Reserve for basically renting our own money, UN dues and other foreign banking interests like the IMF which was allegedly created to fight global financial crisis's, the World Bank, BIS (Bank of International Settlements) and others. That is a fact that should make every American sick to their soul. The fruits of our labor stolen from us to throw around the world for power and massive wealth.

NO WHERE in the U.S. Constitution does it give the U.S. Congress the authority to steal from us to throw to foreign banking entities or the corrupt, communist controlled UN aka United Nothing.

Feds Collect Record Income and Payroll Taxes Through March-Still Run \$526,855,000,000 Deficit: 'Through March, the federal government collected approximately \$695,391,000,000 in individual income taxes. That is about \$7,387,280,000 more than the \$688,003,720,000 in individual income taxes (in constant 2017 dollars) that the federal government collected in the first six months of fiscal 2016."

Almost \$700 BILLION dollars taken out of the economy to pay interest on the worthless currency we're forced to rent from the privately owned "Federal" Reserve and all the rest for transfer payments.

The next question that immediately follows: If not a single function of the federal government is funded by the 'income' tax, how does the government pay the bills they rack up in every bloated budget sent to a president? Every penny is borrowed from the magical money machine called the "Fed" with the interest slapped on our backs, our children and grandchildren and their children. Unpayable debt that is bringing down this country.

Yes, the criminal syndicate called the Outlaw Congress does collect constitutional revenues like corporate taxes, military hardware sales and excise taxes like cigarettes, alcohol, tobacco, firearms, tires and things of that nature. In February 2007, former Congressman Ron Paul proposed an amendment to the U.S. Constitution to abolish personal income, estate and gift taxes. It would have repealed an amendment that was never ratified, the Sixteenth, because Congress will never admit that amendment never became law. He tried again with similar legislation in 1999-2000 and 2001. There was no support in the U.S. House for we the people, the truth or the U.S. Constitution. But, none of this seems to matter to the nearly 100 million Americans who continue to reelect the same liars for hire to the U.S. Congress every two years. As usual during election cycles enthusiastic supporters of incumbents get out there working to get their Congress critter reelected. The same incumbents who have and continue to lie to those enthusiastic supporters about the nature of the 'income' tax. Why? Tommy Cryer was my attorney in the fight out here in Texas to get 'smart' meters banned. In 2006, Tommy Cryer was indicted by the U.S. Department of (In)Justice for two counts of tax evasion. In July of 2007, the IRS reduced the charges to willful failure to file income tax returns. He went to trial and was unanimously acquitted by the jury.

BUT, in no federal court room in this country is a defendant allowed to bring irrefutable facts about the nature of the 'income' tax to a jury and who it applies to in trying to defend themselves. A defendant can use the defense they sincerely believed they were not liable. Most go to prison. Tommy got a jury who saw through the government's lies.

I do not recommend anyone do what Tommy did because the federal judiciary and the U.S. prosecutors are joined at the hip. The collusion is beyond reprehensible, kissed and blessed by YOUR incumbent in the Outlaw Congress. At some point, as with prohibition, something will give or the financial collapse comes first; it's underway, no one should make any mistake about that.

Challenging fraud and wrong doing by governments, state or federal, is our duty and responsibility. As a self-governing people, only we can hold them in check. Tommy's noble fight led him to write a 90-page document titled, *The Memorandum*. Joseph is the highest ranking IRS employee ever to step forward and tell the truth about the nature of the income tax.

Joe's research and subsequent actions by his supervisors eventually caused him to resign from the IRS and a secure future with a handsome paycheck. He was also indicted by the U.S. Department of [In]Justice and went on trial in a federal court room in Sacramento. I attended his trial and literally couldn't stand the drama knowing his freedom could be taken away over a lie. The bottom line is this:

1. Seniors are double taxed for their social security benefits that do not fund what they think it does. Then along comes a bill in Congress to stop the thievery and there was no interest by AARP, Rush Limbaugh, Sean Hannity, any big newspaper or other medium that reaches millions.

H.R. 3894 – Senior Citizens Tax Elimination Act to do away with federal income taxes on social security. Introduced by Rep. Thomas Massie (R-Ky.), January 15, 2014. Referred to House Committee on Ways & Means. Another re-introduction because no one in the Outlaw Congress was interested in helping senior citizens by stopping double taxation. Social Security is a tax. That tax goes to paying you benefits at retirement. Then, they tax you again on those benefits – double taxation. The bill had a whopping two cosponsors and died.

Nothing but more lies because if they did that bill which was introduced in two separate sessions of Congress would have passed in a NY second.
