free range grass fed chickens back then for about \$6.70 and today about the same depending on the company; the highest I saw last week was \$9.00.

The Secretary of Agriculture assessed a penalty against him under the Agricultural Adjustment Act of 1938 because he harvested about 12 acres more wheat than his

allotment under the Act permitted. The Act was designed to regulate the volume of wheat moving in interstate and foreign commerce in order to avoid surpluses and shortages, and concomitant fluctuation in wheat prices, which had previously obtained."

"What a crock. This is Fascism, pure and simple. **Our ranchers and farmers, in a supposedly free enterprise, capitalistic system, are harnessed and restrained by an unconstitutional act and the privately owned Federal Reserve is the silver bullet behind it.** Farmers are told what they can and cannot grow and harvest, what they can and cannot sell, how much, when and at what price.
